SUMMARY

This report seeks Council approval to change the hours of operation of the pick-up/drop-off area on the west side of St. Patrick Street, in front of the Orde Satellite Daycare.

Changing the parking regulations as recommended will match the hours of operation of the daycare and will have little impact on traffic operations on St. Patrick Street, between Dundas Street West and Oueen Street West.

RECOMMENDATIONS

Transportation Services recommends that Council:

- 1. change the existing ten minute maximum parking limit, from 7:30 a.m. to 9:30 a.m. and from 4:30 p.m. to 6:30 p.m., Monday to Friday, on the west side of St. Patrick Street, from a point 54.0 metres south of Dundas Street West to a point 25.0 metres further south thereof, to 7:30 a.m. to 10:00 a.m. and from 3:30 p.m. to 6:30 p.m., Monday through Friday; and
- 2. change the existing "No Parking, from 9:30 a.m. to 4:30 p.m. and from 6:30 p.m. of one day to 7:30 a.m. the next following day" and anytime on Saturday and Sunday, to 10:00 a.m. to 3:30 p.m. and from 6:30 p.m. of one day to 7:30 a.m. of the next following day, Monday to Friday and anytime on Saturday and Sunday.

ISSUE BACKGROUND

At the request of a representative of the Orde Satellite Daycare, 132 St. Patrick Street, and in consultation with staff of Councillor Adam Vaughan's office, Transportation Services has reviewed the feasibility of changing the parking regulations in effect for the daycare pick-up/drop-off area, currently located on the west side of St. Patrick Street, south of Dundas Street West.

COMMENTS

St. Patrick Street operates two-way (northbound and southbound) between Dundas Street West and Queen Street West, on a pavement width of 8.5 metres with a speed limit of 40 km/h. Parking is currently prohibited on the west side of St. Patrick Street, fronting the Orde Satellite Daycare, from 9:30 a.m. to 4:30 p.m. and from 6:30 p.m. of one day to 7:30 a.m. of the next following day, Monday to Friday and on Saturday and Sunday. During the times of operation of the daycare drop-off/pick-up area, from 7:30 a.m. to 9:30 a.m. and from 4:30 p.m. to 6:30 p.m., Monday through Friday, parking is allowed for a maximum period of ten minutes.

Transportation Services concludes the requested amendments to the parking regulations will assist the daycare in its operations with negligible impact on this section of St. Patrick.
