This letter has the purpose of informing you that, similarly to previous years, FESTIVAL PORTUGUESE FRIENDSHIP CLUB INC., will be holding CIRV 88.9FM's annual SUMMERFEST/2007 traditionally held on Father's day weekend, being this year, on Friday, June 15th to Sunday, June 17th and similarly to last year, it will take place at Earlscourt Park, located on St. Clair and Caledonia, in Toronto.

Cirv's Summerfest has been taking place for many years, it is a non profit event that features artists from Portugal/Brazil, USA, as well as local talent.

It also includes contests, dancing music, folklore, kids rides etc;

It is a community event, and it helps to promote the local talent.

We are in the process of applying for a liquor license, since alcohol will be sold there, however, we are sure that similarly to the previous years, the Alcohol and Gaming Commission will have no objection to it.

We have submitted to Toronto Parks and Recreations the application for our community event to be held once again at Earlscourt Park in a City Park to Toronto Parks and Recreations to the attention of Gloria Peters, as well as a letter to Councillor Cesar Palacio advising him of same.

In the meantime, we are hoping that your next Community Council meeting will take place within the next couple of weeks and in view of that, be would like to ask you to please have our event discussed and considered at that meeting and due to the fact that we need your approval to be sent with the liquor application, we would like to ask you to please let us know, as soon as possible the outcome of the council's meeting.

The Alcohol and Gaming Commissions of Ontario will require a letter from the City Clerk designating CIRV FM's Summerfest as a Community Festival.

Please forward us the original if possible by courier, so that we can file with the special eccasion permit application.
