Naming of Proposed Street in Exhibition Place

SUMMARY

This report recommends that the proposed street, south of the new soccer stadium at Exhibition Place, be named “Princes’ Boulevard”, and a portion of Ontario Drive be changed to “Princes’ Boulevard.”

The naming of the streets is required to reconnect the east and west sections of Princes’ Boulevard that have been separated as a result of the new soccer stadium, and to provide a municipal address for the stadium.

RECOMMENDATIONS

The City Surveyor recommends that:

- (1) the proposed street south of the new soccer stadium, extending between the east section of Princes’ Boulevard and Ontario Drive, be named “Princes’ Boulevard”;
- (2) the portion of Ontario Drive extending between the proposed street and the west section of Princes’ Boulevard, be changed to “Princes’ Boulevard”; and
- (3) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto, including the introduction of a naming by-law.

FINANCIAL IMPACT

There are no financial implications resulting from the adoption of this report.

ISSUE BACKGROUND

We have a request from Dianne Young, General Manager and CEO of Exhibition Place, to name the proposed street south of the new soccer stadium, between the east section of Princes' Boulevard and Ontario Drive, "Princes' Boulevard". The portion of Ontario Drive between the proposed street and the westerly section of Princes' Boulevard should be changed to "Princes' Boulevard".

The naming of the streets is required to reconnect the east and west sections of Princes' Boulevard that have been separated as a result of the new soccer stadium, and to provide a municipal address for the stadium.

COMMENTS

Notices to name the streets, under the Municipal Act, 2001, will be given in accordance with the notice requirement set out in Chapter 162-3A of the City of Toronto Municipal Code.

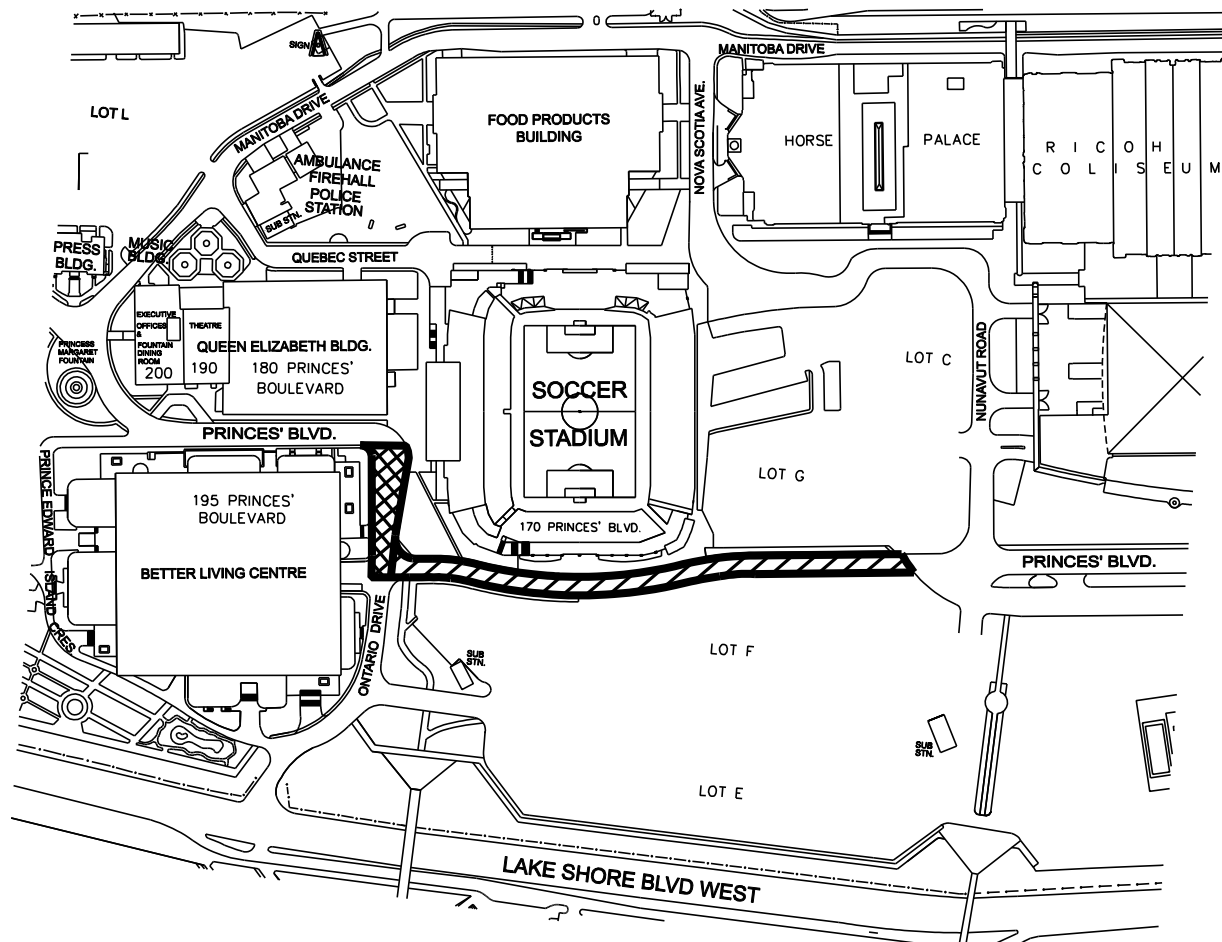
