# Front Street East, east of Scott Street – No Standing Zone

#### SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to amend the parking regulations on the south side of Front Street East, in front of No. 27 Front Street East, to provide a pick-up/drop-off zone in the vicinity of the St. Lawrence Centre.

Implementing a "No Standing" zone will provide a clear area for pick-up/drop-off activities to occur efficiently and safely.

#### RECOMMENDATIONS

## **Transportation Services recommends that Toronto and East York Community Council:**

- 1. prohibit standing at all times on the south side of Front Street East, from Scott Street to a point 31 metres east of Scott Street; and
- 2. amend the existing "No Parking Anytime" regulation on the south side of Front Street East, from Scott Street to a point 67.1 metres east of Scott Street, to be in effect from 31 metres east of Scott Street to a point 67.1 metres east of Scott Street.

#### **ISSUE BACKGROUND**

At the request of Councillor Pam McConnell, on behalf of St. Lawrence Centre representatives, staff reviewed the parking regulations on Front Street East in the vicinity of the St. Lawrence Centre at No. 27 Front Street East. Patrons, particularly elderly patrons, are in need of an area where they can be picked up or dropped off near the entrance.

#### COMMENTS

The existing parking controls, on the south side of Front Street East, between Scott Street and Church Street, are as follows:

- No Parking Anytime from Scott Street to a point 67.1 metres east
- Pay & Display Parking from 67.1 metres east of Scott Street to Church Street

No. 27 Front Street East is located immediately east of Scott Street.

The area controlled by the existing "No Parking Anytime" regulation allows for pick-up and drop-off of passengers, loading/unloading activities, and parking by disabled parking permit holders. We observed occasions when insufficient curb space was available for patrons of the St. Lawrence Centre to be dropped off or picked up.

Introducing a "No Standing" zone at the entrance would allow for pick-up and drop-off of passengers but would not allow parking or loading. This zone would be located on the south side of Front Street East, from Scott Street to a point 31 metres east of Scott Street.
