# Proposed Amendments to Parking Regulations - Dundas Street West, between Dovercourt Road and Sterling Road

(August 17, 2006) report from Director, Transportation Services, Toronto and East York District

# **Committee Recommendations**

The Toronto and East York Community Council recommends that Council:

- 1. adopt and implement as a temporary measure from November 1, 2007 to June 30, 2008 while the Ward Councillor, City Staff and the Toronto Parking Authority consider implementing a long-term parking solution for the area, the following Recommendations contained in Appendix D. "Recission of peak period parking prohibition on both sides of Dundas Street West, between Clarens Avenue and Margueretta Street, between Brock Avenue and Sheridan Avenue and between Gladstone Avenue and Rusholme Drive/Beaconsfield Avenue"
  - "1. the parking prohibition in effect from 7:00 a.m. to 9:00 a.m., Monday to Friday except public holidays, on the north side of Dundas Street West, from College Street to Dovercourt Road, be rescinded;
  - 2. a parking prohibition in effect from 7:00 a.m. to 9:00 a.m., Monday to Friday except public holidays, on the north side of Dundas Street West, from College Street to St. Clarens Avenue, be enacted;
  - *3. a parking prohibition in effect from 7:00 a.m. to 9:00 a.m., Monday to Friday*

except public holidays, on the north side of Dundas Street West, from Margueretta Street to Brock Avenue, be enacted;

- 4. a parking prohibition in effect from 7:00 a.m. to 9:00 a.m., Monday to Friday except public holidays, on the north side of Dundas Street West, from Sheridan Avenue to Gladstone Avenue, be enacted;
- 5. a parking prohibition in effect from 7:00 a.m. to 9:00 a.m., Monday to Friday except public holidays, on the north side of Dundas Street West, from Rusholme Drive/Beaconsfield Avenue to Dovercourt Road, be enacted;
- 6. the parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from College Street to a point 81 metres west of Dufferin Street, be rescinded;
- 7. the parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from a point 67 metres west of Dufferin Street to a point 29.4 metres west of Grove Avenue, be rescinded;
- 8. a parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from College Street to St. Clarens Avenue, be enacted;
- 9. a parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from Margueretta Street to Brock Avenue, be enacted;
- 10. a parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from Sheridan Avenue to a point 81 metres west of Dufferin Street, be enacted;
- 11. a parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from a point 67 metres west of Dufferin Street to Gladstone Avenue, be enacted;
- 12. a parking prohibition in effect from 4:00 p.m. to 6:00 p.m., Monday to Friday except public holidays, on the south side of Dundas Street West, from Rusholme Drive/Beaconsfield Avenue to a point 29.4 metres west of Grove Avenue, be enacted;
- 13. the two-hour pay-and-display parking, in effect from 9:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on both sides of Dundas Street West, from Lansdowne Avenue to a point 45 metres east of Roxton Road, at a rate of \$1.00 for one hour, be rescinded;

- 14. two-hour pay-and-display parking, in effect from 9:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on both sides of Dundas Street West, from Lansdowne Avenue to St. Clarens Avenue, at a rate of \$1.00 for one hour, be enacted;
- 15. two-hour pay-and-display parking, in effect from 8:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the north side of Dundas Street West, from St. Clarens Avenue to Margueretta Street, at a rate of \$1.00 for one hour, be enacted;
- 16. two-hour pay-and-display parking, in effect from 9:00 a.m. to 6:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the south side of Dundas Street West, from St. Clarens Avenue to Margueretta Street, at a rate of \$1.00 for one hour, be enacted;
- 17. two-hour pay-and-display parking, in effect from 9:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on both sides of Dundas Street West, from Margueretta Street to Brock Avenue, at a rate of \$1.00 for one hour, be enacted;
- 18. two-hour pay-and-display parking, in effect from 8:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the north side of Dundas Street West, from Brock Avenue to Sheridan Avenue, at a rate of \$1.00 for one hour, be enacted;
- 19. two-hour pay-and-display parking, in effect from 9:00 a.m. to 6:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the south side of Dundas Street West, from Brock Avenue to Sheridan Avenue, at a rate of \$1.00 for one hour, be enacted;
- 20. two-hour pay-and-display parking, in effect from 9:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on both sides of Dundas Street West, from Sheridan Avenue to Gladstone Avenue, at a rate of \$1.00 for one hour, be enacted;
- 21. two-hour pay-and-display parking, in effect from 8:00 a.m. to 4:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the north side of Dundas Street West, from Gladstone Avenue to Rusholme Drive/Beaconsfield Avenue, at a rate of \$1.00 for one hour, be enacted;
- 22. two-hour pay-and-display parking, in effect from 9:00 a.m. to 6:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on the south side of Dundas Street West, from Gladstone Avenue to Rusholme Drive/Beaconsfield Avenue, at a rate of \$1.00 for one hour, be enacted; and
- 23. two-hour pay-and-display parking, in effect from 9:00 a.m. to 4:00 p.m.,

Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, on both sides of Dundas Street West, from Rusholme Drive/Beaconsfield Avenue to a point 45 metres east of Roxton Road, at a rate of \$1.00 for one hour, be enacted."

- 2. request the Director, Transportation Services, Toronto and East York District to report to the Toronto and East York Community Council at its July 2008 meeting, on the re-implementation of the prohibition of peak period parking on both sides of Dundas Street, between St. Clarens Avenue and Margueretta Street, between Brock Avenue and Sheridan Avenue and between Gladstone Avenue and Rusholme Drive/Beaconsfield Avenue;
- 3. authorize in principal, the prohibition of left-turns on Dundas Street West, between Dovercourt Road and Sterling Road, during the peak periods (7:00 a.m. – 9:00 a.m. and 4:00 p.m. – 6:00 p.m.); and request the Director, Transportation Services, Toronto and East York District report to the next meeting of the Toronto and East York Community Council, on March 27, 2007, on recommended locations where left-turns should be prohibited on Dundas Street West, between Sterling Road and Dovercourt Road; and
- 4. request the Director, Transportation Services, Toronto and East York District to report to the Toronto and East York Community Council on the feasibility of rescinding commercial boulevard parking permits for use as public pay-and-display parking in the Dundas Street area, between Stirling Road and Dovercourt Road, and that the report include recommendations on specific locations.
