# Osler Street – Extension of Overnight On-Street Permit Parking Hours

#### **SUMMARY**

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on the east side of Osler Street, between Dupont Street and Cariboo Avenue, from 12:01 a.m. to 7:00 a.m. to 12:01 a.m. to 6:00 p.m., daily, except Thursdays, April 1 to November 30, and to also rescind the one hour maximum parking regulation.

By extending the overnight on-street permit parking hours and rescinding the one hour maximum parking regulation on the east side of Osler Street, between Dupont Street and Cariboo Avenue, the Toronto Police Service, Parking Enforcement Unit, can effectively control illegal parking through their tagging and towing operations.

#### RECOMMENDATIONS

### Transportation Services recommends that Toronto and East York Community Council:

1. extend the overnight on-street permit parking hours of operation on Osler Street, between Dupont Street and Cariboo Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 6:00 p.m., daily, except Thursdays, April 1 to November 30; and

2. rescind the one hour parking regulation from 8:00 a.m. to 6:00 p.m., on both sides of Osler Street, between Dupont Street and Cariboo Avenue.

#### **ISSUE BACKGROUND**

A request was received from Councillor Adam Giambrone, on behalf of area residents, for the extension of overnight on-street permit parking hours, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 6:00 p.m., daily, except Thursdays, April 1 to November 30, on the east side of Osler Street, between Dupont Street and Cariboo Avenue, along with the rescinding of the one hour maximum parking regulation.

#### **COMMENTS**

Osler Street, between Dupont Street and Cariboo Avenue, is a local street operating in a two-way north/southbound direction with a pavement width of 7.3 metres. The legal speed limit is 40 km/h. There is no TTC service on Osler Street.

Currently, parking is prohibited at all times, except Thursdays, from April 1 to November 30, on the west side of Osler Street, from Dupont Street to Cariboo Avenue. Parking is prohibited on the east side each Thursday, from April 1 to November 30, parking is otherwise allowed for a maximum period of one hour, from 8:00 a.m. to 6:00 p.m., Monday to Saturday; reverting to a maximum period of three hours at all other times, except the hours from 12:01 a.m. to 7:00 a.m., when permit parking is in effect.

Area residents requested the extension of on-street permit parking hours from 7:00 a.m. to 6:00 p.m., to alleviate the problem of long term parking by local auto body businesses.
