Shirley Street between St. Clarens Avenue and Norfolk Street – Proposed amendments to parking regulations

SUMMARY

The purpose of this report is to amend the current “No Parking 8:30 a.m. to 6:00 p.m., Monday to Friday” regulation on the south side of Shirley Street from St. Clarens Avenue to a point 143 metres further east to operate from 8:00 a.m. to 4:00 p.m., Monday to Friday in order to coincide with a student pick-up and drop-off regulation on the north side of Shirley Street.

Amending this “No Parking” regulation to operate between 8:00 a.m. to 4:00 p.m., Monday to Friday to coincide with a student pick-up and drop-off regulation on the north side of Shirley Street will provide residents with an additional two hours of parking in the afternoon/evening and enhance parking operations on this section of Shirley Street.

RECOMMENDATIONS

Transportation Services recommends that:

1. the current “No Parking 8:30 a.m. to 6:00 p.m., Monday to Friday” prohibition on the south side of Shirley Street from St. Clarens Avenue to a point 143 metres further east be amended to operate from 8:00 a.m. to 4:00 p.m., Monday to Friday.

COMMENTS

At the request of Councillor Adam Giambrone, staff of Transportation Services have reviewed the parking regulations on Shirley Street between St. Clarens Avenue and Norfolk Street to determine potential improvements to parking.

Shirley Street between St. Clarens Avenue and Norfolk Street is a local street operating one-way (eastbound) with a pavement width of 6.5 metres and a speed limit of 40 km/h.

A “Student Pick-up & Drop-off Zone” operates on the north side of Shirley Street from a point 81.4 m east of St. Clarens Avenue and a point 43.5 m further east thereof. Parking is permitted on the north side of Shirley Street within the designated “Student Pick-up & Drop-off Zone” for a maximum period of 10 minutes from 8:00 a.m. to 9:00 a.m., 11:30 a.m. to 1:00 p.m. and from 3:00 p.m. to 4:00 p.m., Monday to Friday. Parking is prohibited at all other times on the north side of the subject section of Shirley Street.

Parking is prohibited on the south side of Shirley Street between St. Clarens Avenue and a point 143 m east thereof from 8:30 a.m. to 6:00 p.m., Monday to Friday. The permit parking system is in operation on the south side of Shirley Street between 12:01 a.m. and 7:00 a.m. daily and parking is otherwise permitted for a maximum period of three hours.

In order to enhance parking operations on Shirley Street, the “No Parking 8:30 a.m. to 6:00 p.m., Monday to Friday” regulation on the south side of Shirley Street between St. Clarens Avenue and a point 143 m east thereof should be adjusted to coincide with the operational times of the existing “Student Pick-up & Drop-off Zone”. This will allow residents an additional two hours of parking in the afternoon/evening, reduce vehicle conflicts and improve parking operations on this section of Shirley Street.
