
Dunloe Road at Hawarden Crescent – Proposed amendments to the existing entry restrictions

SUMMARY

The purpose of this report is to amend the existing entry restriction times onto Dunloe Road, from Hawarden Crescent and south thereof, so that they are in effect from September 1 of one year, to June 30 of the next following year.

The amendment to the operational times of the entry restriction onto Dunloe Road, from all directions at Hawarden Crescent will now allow all motorists, including residents, their guests and service vehicles to enter Dunloe Road, north of Hawarden Crescent at any time period in July and August.

RECOMMENDATIONS

Transportation Services recommends that:

1. the existing northbound through prohibition on Dunloe Road at Hawarden Crescent, in effect from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and 3:00 p.m. to 4:00 p.m., Monday to Friday, be adjusted to be in effect for these same hours and days of the week from September 1 of one year, to June 30 of the next following year;
2. the existing eastbound left-turn prohibition from Hawarden Crescent to Dunloe Road, in effect from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and 3:00 p.m. to 4:00 p.m., Monday to Friday, be adjusted to be in effect for these same hours and days of the week from September 1 of one year, to June 30 of the next following year; and

3. the existing westbound right-turn prohibition from Hawarden Crescent to Dunloe Road, in effect from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and 3:00 p.m. to 4:00 p.m., Monday to Friday, be adjusted to be in effect for these same hours and days of the week from September 1 of one year, to June 30 of the next following year;

ISSUE BACKGROUND

At the request of Councillor Michael Walker, on behalf of residents of Dunloe Road, staff of Transportation Services have investigated the feasibility of amending the existing entry restriction times to northbound vehicular traffic onto Dunloe Road from Hawarden Crescent, so that they coincide with the operational times of the existing “No Stopping” area located on the east side of Dunloe Road, from Hawarden Crescent to Archer Road.

COMMENTS

Dunloe Road, from Hawarden Crescent to Archer Road, operates two-way on a pavement width of 8.5 metres with a maximum speed limit of 40 kilometres per hour.

Forest Hill Public School is situated on the west side of the subject section Dunloe Road, and the Dunloe Children’s Centre (a daycare) operates within the school. In order to facilitate student pick-up and drop-off activity for children attending the school as well as the daycare, a “Student Pick-up/Drop-off” zone operates on the west side of Dunloe Road. Within this described area, stopping is prohibited from 9:15 a.m. to 11:30 a.m. and from 1:15 p.m. to 3:00 p.m., Monday to Friday, and parking is permitted for a maximum period of 15 minutes from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and 3:00 p.m. to 6:00 p.m., Monday to Friday. Parking is also prohibited from 6:00 p.m. to 8:00 a.m., Monday to Friday and at anytime Saturdays and Sundays.

On the east side of the subject section of Dunloe Road, from Hawarden Crescent to a point 127.5 metres further north, stopping is prohibited from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and 3:00 p.m. to 4:00 p.m., Monday to Friday, from September 1 to June 30. Parking is permitted for a maximum period of one hour from 9:15 a.m. to 11:30 a.m. and from 1:15 p.m. to 3:00 p.m., Monday to Friday, from September 1 to June 30. On the section of Dunloe Road, from a point 127.5 metres north of Hawarden Crescent to a point opposite Archer Road, parking is permitted for a maximum period of one hour from 8:00 a.m. to 6:00 p.m., Monday to Friday. Parking is otherwise permitted for a maximum period of three hours at other times.

Entry to northbound Dunloe Road is currently prohibited from all directions at Hawarden Crescent from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m., and from 3:00 p.m. to 4:00 p.m., Monday to Friday. Councillor Walker, on behalf of the residents of Dunloe Road, has requested that the existing northbound entry restrictions onto Dunloe Road, from Hawarden Crescent, not be in effect from July 1 to August 31. The parking regulations on this section of Dunloe Road were originally implemented as a means of controlling the large volumes of vehicular traffic on Dunloe Road during the times that school pick-up and drop-off activities were taking place on Dunloe Road. As Forest Hill Public School and the Dunloe Children's Centre are not operational during July and August, the existing vehicular entry controls are not necessary during these months.
