Pearson Avenue – Extension of Overnight On-Street Permit Parking Hours

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on the south side of Pearson Avenue, between Roncesvalles Avenue and Sorauren Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week.

By extending the overnight on-street permit parking hours, the Toronto Police Service, Parking Enforcement Unit, can effectively control the long term parking of patrons visiting nearby businesses on Roncesvalles Avenue.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. extend the overnight on-street permit parking hours of operation on Pearson Avenue, between Roncesvalles Avenue and Sorauren Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week.

ISSUE BACKGROUND

A request was received from Councillor Gord Perks, on behalf of area residents, for the extension of overnight on-street permit parking hours, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week, on the south side of Pearson Avenue, between Roncesvalles Avenue and Sorauren Avenue.

COMMENTS

Pearson Avenue, between Roncesvalles Avenue and Sorauren Avenue, is a local street operating in a one way east bound direction with a pavement width of 6.1 metres. There is no TTC service on Pearson Avenue.

Currently, parking is prohibited at all times, on the north side of Pearson Avenue, between Roncesvalles Avenue and Sorauren Avenue. Parking is allowed for a maximum period of three hours at all other times, except during the hours from 12:01 a.m. to 7:00 a.m., when permit parking is in effect.

Area residents requested the extension of on-street permit parking hours from 7:00 a.m. to 10:00 a.m., to alleviate the problem of long term parking by patrons visiting nearby businesses on Roncesvalles Avenue.
