Allocation Recommendations

Recommendations:

The Community Partnership and Investment Program Appeals Sub-Committee recommends to the Community Development and Recreation Committee that:

- 1. The allocations for the Parks, Forestry and Recreation portion of the 2008 Community Festival and Special Events Investment Program totalling \$89,078 as per Attachment No. 1 be approved.
- 2. \$10,982 be set aside for the appeals process.
- 3. The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

Decision Advice and Other Information:

The Community Partnership and Investment Program Appeals Sub-Committee:

- a. referred the appeals from the following organizations to the General Manager, Parks, Forestry and Recreation for further consideration and report to the Community Development and Recreation Committee for its meeting on June 9, 2008, or, if necessary, City Council on June 23, 2008:
 - Chi-Ping Dance Group (ID Number CF1);
 - West Hill Community Services (ID Number CF6);
 - Community Centre 55 (ID Number CF19);
 - St. Jamestown Festival (ID Number CF32); and
- b. requested the General Manager, Parks, Forestry and Recreation to review the channels of communication with organizations, in order to reduce the number of late applications.

Background:

The Community Partnership and Investment Program Appeals Sub-Committee on June 3, 2008, considered a report (May 12, 2008) from the General Manager, Parks, Forestry and Recreation recommending allocations for the Parks, Forestry and Recreation portion of the 2008 Community Festivals and Special Events (CFSE) Investment Program.

Recommendations:

The General Manager, Parks, Forestry and Recreation recommends that:

- 1. The Community Partnership and Investment Appeals Sub-Committee approve the allocations for the Parks, Forestry and Recreation portion of the 2008 Community Festival and Special Events Investment Program totalling \$89,078 as per Attachment No. 1.
