The Community Partnership and Appeals Sub-Committee referred the appeal from the St. Clair Gardens BIA to the Director, Small Business and Local Partnerships for further review and reporting to the meeting of the Economic Development Committee to be held on June 12, 2008. This report recommends that the CFSE Investment Program Economic Development appeal funds of \$2,845.00 be divided amongst the St. Clair Gardens BIA and the other eligible first year applicants as per Attachment No. 1.
