**NAMING** the proposed private lane at 252 to 276 Bering Avenue as “**Lobo Mews**”.

At its meeting to be held in the Council Chamber at the Etobicoke York Civic Centre, on **February 12, 2008** at 10:00 a.m., the Etobicoke York Community Council will hear in person or be his or her counsel, agent or solicitor, any person who claims that his or her lands will be prejudicially affected by the proposed by-law and who applies to be heard, with respect to the proposed by-law.

**Notice to people writing or making a presentation to the Etobicoke York Community Council:** The City of Toronto Act, 2006 and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address – available to the public, unless you expressly request the City to remove it.

The City videotapes committee and community council meetings. If you make a presentation to a committee or community council, the City will be videotaping you and the City staff may make the video tapes available to the public.
