PROPOSAL

The applications to amend the Zoning By-law and Official Plan propose to permit one ten storey residential condominium with a maximum of 84 units at the site across from 21 Old Mill Road. The proposal also includes a four-storey underground parking garage. The proposed garage will include 124 parking spaces for the new residents and visitors of the new condominium building and an additional 100 spaces to be used in conjunction with the existing Old Mill conference centre/banquet hall. Vehicular and servicing access to the development will be from Old Mill Road, at the east end of the building. Public benefits under Section 37 of the Planning Act will also be provided.



Official Plan and Zoning By-law Amendments Appeal: If a person or public body that files an appeal of a decision of the City of Toronto in respect to the proposed Official Plan and Zoning By-law Amendments, does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Glenda Jagai, Administrator, Etobicoke York Community Council, at the address set out in this notice or by Fax: 416-394-8895 before the proposed Official Plan and Zoning By-law Amendments is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.
