

**95 Regal Road – Amendment to Parking Regulations**

**SUMMARY**

This staff report is about a matter for which the community council has delegated authority from City Council to make a final decision.

The purpose of this report is the implementation of more restrictive regulation preventing parents from blocking both sides of Regal Road, in front of and across from, Regal Road Public School.

The proposed parking amendments will alleviate congestion and enhance the pedestrian crossing and traffic safety environment in front of and across the school on Regal Road.

**RECOMMENDATIONS**

**Transportation Services recommends that Etobicoke York Community Council approve:**

1. Amending the parking regulations on Regal Road as set out in Appendix “B” and generally as shown in attached drawing No. EY08 – 84

## **ISSUE BACKGROUND**

Councillor Cesar Palacio, on behalf of area residents, the principal of Regal Road Public School and in consultation with Transportation Services staff, requested a review into the feasibility of rescinding the existing parking prohibition on the south side of Regal Road and the existing standing prohibition on the north side of Regal Road, in the vicinity of Regal Road Public School to alleviate congestion.

## **COMMENTS**

Regal Road is a local road in the residential community located east of Dufferin Street and north of Davenport Road with a road width of approximately 7.3 metres and a posted speed limit of 40 km/h. There are sidewalks on both sides of this street. The existing parking regulation in the vicinity of Regal Road Public School are described in Appendix “A” and shown on Drawing No. EY08-83.

Implementing a stopping prohibition between 8:30 a.m. and 6:00 p.m., daily on the north side of Regal Road and a stopping prohibition at all times on the south side of Regal Road in the vicinity of Regal Road Public School, will eliminate the congestion created by parents parking in the vicinity of the School Bus Loading Zone. The proposed amendments to the parking regulations are described in Appendix “B” and shown on Drawing No. EY08 - 84.

## Appendix “A”

### Parking regulations in the vicinity of Regal Road Public School

#### South Side

- Parking is allowed for a maximum period of ten-minutes from 7:00 a.m. to 6:00 p.m., Monday to Friday, on the south side of Regal Road from a point 15 metres east of Dufferin Street to a point 61 metres further east;
- Parking is allowed for a maximum period of ten-minutes from 7:00 a.m. to 6:00 p.m., Monday to Friday, on the south side of Regal Road from a point 119 metres east of Dufferin Street to a point 56 metres further east;
- Parking is prohibited at all times on the south side of Regal Road, between Dufferin Street to a point 15 metres east thereof;
- Parking is prohibited at all times on the south side of Regal Road, between a point 76 metres east of Dufferin Street to a point 43 metres east thereof;
- Parking is prohibited at all times on the south side of Regal Road, between a point 175 metres east of Dufferin Street to Oakwood Avenue;
- Parking is prohibited at other times on the south side of Regal Road, between a point 15 metres east of Dufferin Street to a point 61 metres east thereof;
- Parking is prohibited at other times on the south side of Regal Road, between a point 119 metres east of Dufferin Street to a point 56 metres east thereof; and
- A school bus loading zone be designated on the south side of Regal Road between a point 95.0 metres east of Dufferin Street to a point 24.0 metres east thereof;

#### North Side

- Standing is prohibited on Regal Road, opposite the school, between 8:30 a.m. and 6:00 p.m., daily, and parking is allowed for a maximum period of 3 hours outside of the hours of permit parking operation between 12:01 a.m. and 7:00 a.m., daily.

## Appendix “B”

1. The existing parking prohibition at all times on the south side of Regal Road, between a point 76 metres east of Dufferin Street to a point 43 metres east thereof, be rescinded;
2. The existing standing prohibition from 8:30 A.M. to 6:00 P.M., daily on the north side of Regal Road, between Dufferin Street and Northcliffe Boulevard, be rescinded;
3. Stopping be prohibited at all times on the south side of Regal Road, between a point 76 metres east of Dufferin Street to a point 43 metres east thereof; and
4. Stopping be prohibited from 8:30 A.M. to 6:00 P.M., daily on the north side of Regal Road, between Dufferin Street and Northcliffe Boulevard thereof.
