### Bartonville Avenue West – Amendments to Parking Regulations

#### SUMMARY

---

This staff report is about a matter for which the community council has delegated authority from City Council to make a final decision.

The purpose of this report is to prohibit parking at all times on the south side of Bartonville Avenue West, between Weston Road and a point 41.0 metres further west thereof.

Staff recommends implementing the parking prohibition at all times on this section of Bartonville Avenue West to eliminate vehicles parking for longer periods of time and blocking driveways in this vicinity.

#### RECOMMENDATIONS

**Transportation Services recommends that the Etobicoke York Community Council approve:**

1. That parking be prohibited at all times on the south side of Bartonville Avenue West from Weston Road to a point 41.0 metres further west thereof.

## **ISSUE BACKGROUND**

Councillor Frances Nunziata, on behalf of area residents, requested Transportation Services staff to review the feasibility of implementing a parking prohibition at all times on the south side of Bartonville Avenue West, from Weston Road to a point 41.0 metres further west thereof, to eliminate vehicles parking for longer periods of time and blocking driveways.

## **COMMENTS**

Bartonville Avenue West is a local roadway providing two-way traffic flow on a pavement width of 7.1 metres and a speed limit of 40 km/h. Parking is prohibited at all times on the north side of Bartonville Avenue West, between Weston Road and the westerly terminus of the street. Permit parking is in effect from 12:00 Midnight to 6:00 a.m. and parking is allowed for a maximum period of three hours at all other times on the south side of Bartonville Avenue West, between Weston Road and the westerly terminus street.

Vehicles park on the south side of Bartonville Avenue for longer than one hour and block existing driveways. This is inconvenient for residents to enter and exit their driveways. Prohibiting vehicles from parking at all times on the south side of Bartonville Avenue West, from Weston Road to a point 41.0 metres further west thereof will prevent motorists from blocking these driveways, creating a safer traffic environment.
