**SUMMARY**

---

This staff report is about a matter for which the community council has delegated authority from City Council to make a final decision.

This report recommends that the proposed public street at the residential development at 315 and 325 Dalesford Road be named “Gala Lane”. Naming the street will facilitate the identification of the proposed units fronting thereon.

**RECOMMENDATIONS**

---

The City Surveyor recommends that:

- (1) the proposed public street at 315 and 325 Dalesford Road, be named “Gala Lane” and dedicated for public highway purposes by By-Law; and
- (2) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto, including the introduction of a naming by-law.

**FINANCIAL IMPACT**

There are no financial implications resulting from the adoption of this report.

**ISSUE BACKGROUND**

We have a request from Paul Federico of Berkley Developments (20 Rivermede Road, Suite 204, Concord, ON L4K 3N3) to name the proposed public street at the residential development at 315 and 325 Dalesford Road, as shown on Attachment No. 1. Naming the street will facilitate identification of the proposed units fronting thereon.

The name “Gala Lane” has been suggested by the Etobicoke York Preservation Panel as the name “Gala” commemorates a variety of apple once grown in Ontario and in the Etobicoke area.

## **COMMENTS**

The proposed name has been circulated for comment and is acceptable to Councillor Milczyn, Berkley Developments, Police, Fire and Emergency Medical Services.

The name conforms with item 1 (b), Criteria For Name Selection, as set out in City Council’s street naming policy – “to commemorate local history, places, events or culture”.

Notices to name the street, under the *City of Toronto Act, 2006*, will be given in accordance with the notice requirement set out in Chapter 162-3A of the City of Toronto Municipal Code.

The proposed name “Gala Lane” is consistent with the City of Toronto Street Naming Policy approved by City Council at its meeting held on August 1, 2, 3 and 4, 2000 (Clause 9, Report 15 of the Works Committee) and should therefore be approved for identifying the proposed public street.

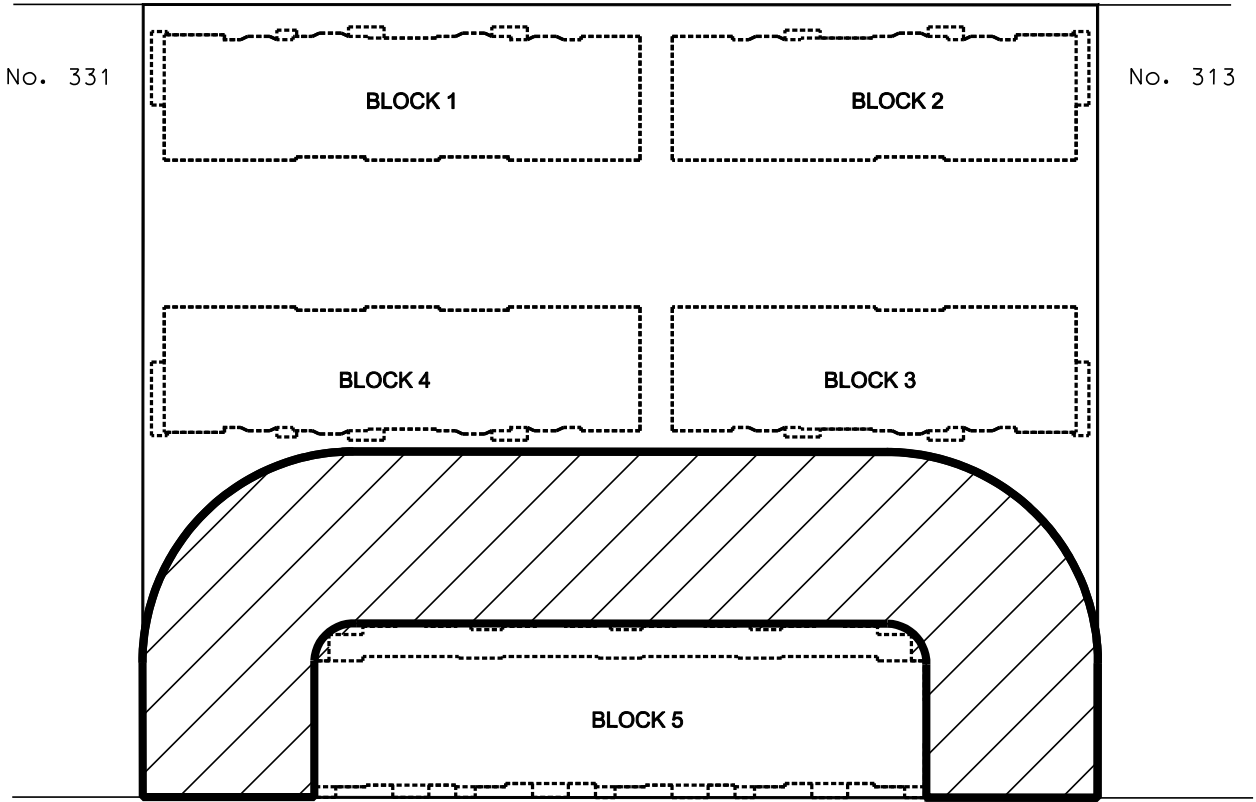

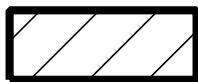
