SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to propose the installation of a "Maximum 10 Minute Limit, 8:00 a.m. to 5:00 p.m., Monday to Friday" parking regulation on the east side of Princess Anne Crescent along St. George's School property.

This proposed regulation will give the parents wishing to accompany children into the school an area for short duration parking.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

- 1. Rescinding the existing "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" prohibition on the east side of Princess Anne Crescent between Prince George Drive and Princess Margaret Boulevard.
- 2. Enacting a "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" prohibition on the east side of Princess Anne Crescent between Princess Margaret Boulevard to a point 135.0 metres south thereof.

- Enacting a "Maximum 10 Minute Limit, 8:00 a.m. to 5:00 p.m. Monday to Friday" parking restriction on the east side of Princess Anne Crescent from a point 135.0 metres south of Princess Margaret Boulevard to a point 85.0 metres south thereof.
- 4. Enacting a "No Parking, 8:00 a.m. to 5:00 p.m., Monday to Friday" prohibition on the east side of Princess Anne Crescent between a point 47.0 metres north of Prince George Drive and Prince George Drive.

ISSUE BACKGROUND

Transportation Services staff recently attended a meeting with the principal and parents of St. George's School. At this meeting, it was requested that an area be created to accommodate parents wishing to park and accompany children into the school. A map of the area is Attachment No. 1.

COMMENTS

St George's School is located on the southwest corner of Princess Anne Crescent and Princess Margaret Drive. Princess Anne Crescent and Princess Margaret Boulevard both have sidewalks on the school side with legal speed limits of 40 km/h. Current parking regulations prohibit parking along the school frontage between 8 a.m. and 5 p.m., Monday to Friday on both streets. In addition, a "No Stopping 8 a.m. to 5 p.m., Monday to Friday" regulation is posted on the opposite side of both streets.

Based on staff's examination of this matter, and consultation with the school principal, it is recommended that short duration parking (maximum 10 minutes) be allowed between 8:00 a.m. and 5:00 p.m., Monday to Friday on a portion of the east side of Princess Anne Crescent abutting the school property. This will provide a legal area for those parents who wish to park and walk their children into the school. The principal of the school is supportive of this recommendation.
