SUMMARY

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval for the installation/removal of a number of on-street parking spaces for person with disabilities.

RECOMMENDATIONS

Transportation Services recommend that Etobicoke York Community Council approve:

1. Installing and removing on-street parking spaces for persons with disabilities at various locations as identified in the attached Appendix A.

ISSUE BACKGROUND

Transportation Services receives numerous requests for the installation and removal of onstreet parking spaces for persons with disabilities. Some of these requests come directly from members of the public and others are received through the local Councillors' offices. The installation of designated on-street parking spaces for persons with disabilities is a convenience provided for disabled persons and/or those who transport them, making it easier for them to find available parking as near as possible to their places of residence or intended destinations and reducing the distance that the disabled persons must walk. Delays in installing these requested on-street spaces may create hardships for disabled applicants.

Timely removal of designated on-street parking spaces for persons with disabilities when these on-street spaces are no longer required is necessary in order to maximize available on-street parking for other residents and motorists.

COMMENTS

Transportation Services Division staff investigated the feasibility of installing and/or removing on-street parking spaces for persons with disabilities at various locations as identified in the attached Appendix A to this report. None of these sections of roadway are served by Toronto Transit Commission (TTC) routes.

For locations where on-street disabled person's parking spaces are being established, all applicants are holders of valid Accessible Parking Permits issued by the Ministry of Transportation and each designated space will not result in the loss of more than one on-street parking space for general use. Locations where on-street disabled persons' parking spaces are to be removed are the result of applicants moving, holding expired permits or no longer requiring these on-street parking spaces.

On-street parking spaces for persons with disabilities to be removed:

Ward	Location
17	Brandon Avenue, south side, between a point 33.2 metres east of Primrose Avenue and a point 5.5 metres further east.
17	McRoberts Avenue, east side, between a point 57 metres north of Rogers Road and a point 5.5 metres further north.
17	Peterborough Avenue, north side, between a point 345 metres east of Via Italia and a point 5.5 metres further east.

On-street parking spaces for persons with disabilities to be installed:

<u>Ward</u>	Location
11	Craydon Avenue, south side, between a point 136.5 metres east of Weston Road and a point 5.5 metres further east.
17	Brandon Avenue, south side, between a point 13 metres east of Primrose Avenue and a point 5.5 metres further east.
