SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to propose the changing of a “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation to a “No Parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday” prohibition on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road.

Given that all the affected property owners on Meadowvale Drive support this proposed parking amendment, we are recommending the aforementioned parking prohibition on this road.

RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. Rescinding the “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation on the north side of Meadowvale Drive between Prince Edward Drive and Royal York Road.
2. Enacting a “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation on the north side of Meadowvale Drive between Prince Edward Drive and Humbervale Boulevard.

3. Enacting a “No Parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday” prohibition on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road.

ISSUE BACKGROUND

The Transportation Services Division, Etobicoke York District, received a petition from area residents to investigate the feasibility of changing the existing “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation to a “No Parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday” prohibition on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road. This request is the result of the excessive and long-term parking that is occurring on this road. A map of the area is Attachment No. 1.

COMMENTS

Meadowvale Road, east of Royal of Royal York Road, is a local residential road having no curbs, gutters or sidewalks. Speed humps are located on Meadowvale Drive between Prince Edward Drive and Royal York Road.

Parking is currently prohibited anytime on the south side of Meadowvale Drive between Prince Edward Drive and Royal York Road. A “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation exists on the north side of the road between Prince Edward Drive and Royal York Road.

As a result of the concerns of area residents, Transportation Services staff sent out a parking survey to the owners of the two affected residential properties on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road. This survey received a response and support rate of 100% for the proposed installation of a “No Parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday” prohibition on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road.

Based on our review of this matter and the favourable response from the affected property owners, staff recommends the changing of the current “One Hour, 8:00 a.m. to 6:00 p.m., Monday to Saturday” parking regulation to a “No Parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday” prohibition on the north side of Meadowvale Drive between Humbervale Boulevard and Royal York Road.
