## **Beaumonde Heights Drive - Speed Limit Amendment**

#### **SUMMARY**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to obtain approval to reduce the speed limit on Beaumonde Heights Drive.

Installing a 40 km/h speed limit on Beaumonde Heights Drive is consistent with the 40 km/h Speed Limit Warrant. Approval of this report will result in a 40 km/h speed limit being posted on Beaumonde Heights Drive between Islington Avenue and the westerly intersection of Monterry Drive.

#### RECOMMENDATIONS

Transportation Services recommends that Etobicoke York Community Council approve:

1. A 40 km/h speed limit on Beaumonde Heights Drive between Islington Avenue and Monterry Drive (west intersection), as the requirements of the 40 km/h Speed Limit Warrant are achieved.

#### **ISSUE BACKGROUND**

Transportation Services staff received correspondence from Councillor Suzan Hall's office regarding concerns with speeding on the street, especially in the vicinity of the curves in the road. To quantify concerns, speed studies were conducted by Transportation Services staff on Beaumonde Heights Drive. The study results were applied to the 40 km/h Speed Limit Warrant. A map of the area is Attachment No. 1.

#### COMMENTS

Beaumonde Heights Drive is a local two-way roadway located west of Islington Avenue and south of Finch Avenue West. The surrounding land area consists of detached single family dwellings. The statutory speed limit for Beaumonde Heights Drive is an unposted 50 km/h. Beaumonde Heights Drive is built to urban standards (curb and gutter) with sidewalks on both sides of the street.

Automatic speed and volume studies were conducted on Beaumonde Heights Drive. These study results reveal that the majority of motorists travel at speeds less than the 50 km/h speed limit with an 85<sup>th</sup> percentile speed of 39 km/h. The 85<sup>th</sup> percentile is the speed at or below which the majority of motorists feel comfortable travelling under the existing roadway conditions. The 24-hour volume was recorded as 756 vehicles.

Toronto Police Service collision records for a three-year period ending December 31, 2007, indicate that there have been no reported collisions in which speed was indicated as a factor on Beaumonde Heights Drive.

Under the current Council Policy, 40 km/h speed limits may be implemented on streets where the Road Width and either Pedestrian or Road and Traffic Environment criteria are met. Beaumonde Heights Drive satisfies the Road Width and Traffic Environment as set in the attached Appendix A: Table 1, since there are two curves with a safe travel speed of less than 40 km/h. It is prudent to reduce the speed limit to reflect these conditions.
