# SUMMARY

This staff report is about a matter for which community council has delegated authority from City Council to make a final decision.

The purpose of this report is to propose the installation of the "No Standing, 6:00 p.m. to 12:00 a.m." prohibition on the north side of Bloor Street West between a point 56 metres west of Royal York Road and a point 14 metres west thereof.

Given that the Kingsway Theatre at 3030 Bloor Street West has reopened, the standing prohibition is required once again for pick-up/drop-off of theatre patrons. As a result, we are recommending the reinstatement of a No Standing prohibition after 6:00 p.m. in front of the theatre.

# RECOMMENDATIONS

#### **Transportation Services recommends that Etobicoke York Community Council Approve:**

1. Enacting a "No Standing , 6:00 p.m. to 12:00 a.m." prohibition on the north side of Bloor Street West between a point 56 metres west of Royal York Road, and a point 14 metres west thereof.

### **ISSUE BACKGROUND**

The Transportation Services Division, has received requests from the management of The Kingsway Theatre, 3030 Bloor Street West, to have a No Standing prohibition installed on the north side of Bloor Street West, west of Royal York Road, in front of the theatre. The Kingsway Theatre has re-opened after being closed for over two years. A standing prohibition did exist on the north side of Bloor Street in front of The Kingsway Theatre prior to its closing. This standing prohibition was removed in March 2007, as per by-law 228-2007.

A map of the area is Attachment No. 1.

### COMMENTS

Currently, parking is prohibited anytime on the north side of Bloor Street West between Royal York Road a point 56 metres west of thereof. A "pay and display" zone is located between a point 56 metres west of Royal York Road and Brentwood Road North. The pay and display zone is in operation between the hours of 9:00 a.m. and 6:00 p.m. The 3hour maximum City-wide parking by-law is effect outside of the pay and display operating hours.

Given that the Kingsway Theatre has re-opened, there is a need to reinstate a standing prohibition in front of 3030 Bloor Street West, after 6:00 p.m. Based on the aforementioned, staff recommends the installation of a "No Standing, 6:00 p.m. to 12:00 a.m." prohibition on the north side of Bloor Street West between a point 56 metres west of Royal York Road and a point 14 metres west thereof. This proposed standing prohibition will address the need for passenger drop-off/pick-up in front of the Kingsway Theatre.
