# Jay Jays Inn - 2847 Lake Shore Boulevard West

#### SUMMARY

Jay Jays Inn operates at 2847 Lake Shore Boulevard West and has been inspected by Toronto Public Health (TPH) on a regular basis. This premise operates as a restaurant with an Adult Entertainment section and is licensed by the Alcohol and Gamming Commission of Ontario and Toronto Licensing Commission. Inspections conducted over the past few years have resulted in minor infractions, notices to comply were issued and compliance was found on the follow-up inspections.

#### **Financial Impact**

There are no financial implications relating to this report at this time.

#### **DECISION HISTORY**

At its meeting on May 26 and 27, 2008, City Council authorized Municipal Licensing and Standards, Public Health, Toronto Fire Services and other departments, as appropriate, to take a proactive approach to regular monitoring and inspections of Jay Jays Inn "Gentlemen's Club" at 2847 Lake Shore Boulevard West, to ensure full compliance with City regulations and by-laws, and to deal with any infractions immediately.

City Council also directed staff, as appropriate, to report to the November 18, 2008 meeting of the Etobicoke York Community Council on:

- a. noise violations;
- b. liquor license violations;
- c. Property Standards infractions;
- d. licensing issues;
- e. Fire Code violations; and
- f. health-related issues.

### **ISSUE BACKGROUND**

TPH conducts inspection of all food premises under the authority of the Health Protection and Promotion Act and Regulation 562/90 (Food Premises). These inspections and the application of this legislation are intended to ensure that premises are operated and maintained in a sanitary condition and that food is prepared and served in a safe manner.

Jay Jays Inn operates at 2847 Lake Shore Boulevard West and has been inspected by TPH on a regular basis. This premise operates as a restaurant with an Adult Entertainment section and is licensed by the Alcohol and Gamming Commission of Ontario and Toronto Licensing Commission.

A review of the file regarding this business reveals that over the last few years inspectors have identified minor infractions and notices to comply were issued and complied with. The most recent inspections were conducted on July 9, 2008 (minor infraction – roof leak, pass issued after compliance), and October 27, 2008 (pass issued).

### COMMENTS

TPH will continue to inspect this premise and ensure that it is operated and maintained in accordance with all public health legislation. In addition, TPH will take all necessary legal action in the event of repeated non-compliance public health issues.
