Summary

Recently, a number of high profile incidents of crime including shootings and stabbings have raised concerns over community safety and violence in the former Cities of York and Toronto. This raises the need for a complete, community-driven approach in dealing with crime and crime prevention initiatives. Problem addresses and establishments, including public places, have become a pervasive problem that require complete co-operation of all City departments, government agencies and stakeholders to resolve.
