Financial Impact

There are no financial implications to Toronto Long-Term Care Homes and Services operating budget arising out of this report.

Summary

Each home has a variety of donations accounts and Toronto Long-Term Care Homes and Services has an overarching policy that requires any expenditure request from a donations account to have the support and endorsement of both the Home Advisory Committee and the General Manager. Further, expenditure requests over the amount of \$5,000.00 also require the endorsement of the Advisory Committee on Long-Term Care Homes and Services.

The policy related to designated uses of the donations account states that expenditures shall not be made for the ordinary operation and maintenance of the home. The policy further states that the purpose of the donations accounts is to enrich or enhance the quality of life for residents. The Wesburn Manor Home Advisory Committee reviewed and unanimously approved this expenditure request in the amount of \$8,000.00 at their meeting of May 13, 2008. Follow-up Report Regarding Kendleton Seniors' Club

(June 5, 2008) Report from General Manager, Long-Term Care Homes and Services

Financial Impact

There are no financial implications arising out of this report. Funding for the Kendleton Seniors' Club was provided by Human Resources and Social Development Canada. The program will be sustained beyond 2008 through club members' fundraising activities such as bake sales or garage sales and through the charging of nominal fees for selected events. TCHC is providing the free use of meeting space and garden areas by the Kendleton Seniors' Club.

Summary

On January 3, 2007, staff from the supportive housing program supported clients residing at 111 Kendleton Drive in applying for and receiving a \$12,416.00 grant from Human Resources and Social Development Canada (HRSDC) to form the Kendleton Seniors' Club. The club was envisioned as a forum to benefit both supportive housing clients at 111 Kendleton and seniors in the adjacent Toronto Community Housing Corporation (TCHC) buildings at 101 and 121 Kendleton Drive.

The club's objectives were to provide seniors with opportunities to participate in social programs, to decrease social isolation, and to share and develop new skills such as crocheting, knitting, gardening, etc. The club has achieved significant success to date, including increased community engagement amongst participating seniors, the development of social cohesion and expansion of intergenerational programming. This report will provide an update on the progress to date and future plans of the Kendleton Seniors' Club.

Role of Advisory Committee on Long-Term Care Homes and Services in the Accreditation Experience (Qumentum)

(June 9, 2008) Report from General Manager, Long-Term Care Homes and Services

Financial Impact

There are no financial implications arising out of this report.

Summary

In March 2008, after months of planning, the Long-Term Care Homes and Services Division signed an agreement with Accreditation Canada to move to a division-wide accreditation and survey experience in 2009. The 2009 survey is planned for the week of March 24, 2009 and will involve all ten (10) homes, the four (4) adult day programs, supportive housing and homemakers and nurses services.

The revised Accreditation Canada standards that will be utilized in the 2009 survey experience are organized around the following areas: Effective and Sustainable Governance, Proactive and Supportive Organization, Medication Management, Infection Prevention and Control, Long-Term Care and Community Health Services. In addition to the standards areas, the division will be assessed for compliance to the 'required organizational practices' including safety goals related to culture, communication, medication management, infection prevention and control, falls management, worklife – workforce, hand hygiene, skin and wound care, suicide prevention and high risk medications. The revised accreditation program also includes 'survey instruments', i.e. individual on-line surveys that will be completed by individual members of staff related to safety and worklife. By 2009, Accreditation Canada expects to have a survey instrument available to measure resident/family satisfaction.

The survey instruments are completed in advance of the survey visit, with all data submitted on-line to Accreditation Canada. Upon receipt of the raw data, Accreditation Canada summarizes the data and provides the summaries back to the organization, in the format of a 'quality roadmap plan' (QRP) to guide improvement work. The QPR will be categorized with green, yellow and red flags indicating the priority areas for re-assessment and/or improvement work.

At the April 2008 and May 2006 meetings of the Advisory Committee on Long-Term Care Homes and Services, the committee began a review of the revised Accreditation Canada Governance standards, with the objective of identifying how the committee will best be able to support the division in the accreditation experience. This report provides an update to that initial discussion.

Decision Advice and Other Information

The Advisory Committee on Long-Term Care Homes and Services, on June 20, 2008, received the report (June 5, 2008) from General Manager, Long-Term Care Homes and Services and an overview of a draft workplan to clarify the role of the Advisory Committee on Long-Term Care Homes and Services. (Qumentum)

The General Manager, Long-Term Care Homes and Services will report back at its meeting of July 18, 2008, on the updated work plan.
