3.0 Dental Services Presentation

Dr. Michele Wong presented a brief overview of the dental cases they see on a daily basis. Some of the challenges for their clients include language, transportation, lack of dental knowledge, lack of dental education to parents, cost for healthy food and restricted clinic hours. The presentation was followed by a question and answer period. Members requested a list of Public Health dental clinic locations.

4.0 Traffic Air Pollution in Toronto

Monica Campbell provided a presentation to address enquires made by members at the last LHC Meeting. The presentation was based on the information contained in a recent study released by the MOH titled "Air Pollution Burden of Illness from Traffic in Toronto: Problems and Solutions". The study includes a quantitative assessment of the burden of illness and economic sots from traffic pollution in Toronto. The report also examines air pollution traffic trends in Toronto and provides an overview of initiatives underway or planned by the City to further combat vehicle-related air pollution.

The presentation was followed by a question and answer period. Monica distributed three copies of the report at the meeting. Members can also access the report by visiting: http://www.toronto.ca/health/hphe

A motion was made by Thomas Marquette that LHC submit a letter to TTC and Mississauga Transit with copies to Mayor Hazel McCallion of Mississauga to address the following issues:

- 1) to develop an "idle free" policy for public transit system in Toronto and Mississauga
- 2) to investigate options for particle traps in the bus terminals
- 3) to explore light rapid transit

The motion was seconded by Marcel Beals, and unanimously carried.

ACTION: LHC, with the support of TPH staff, to draft a letter to TTC and Mississauga Transit

5.0 LHC Priority Setting

- 5.1 Members were divided into 4 groups to itemize their local health issues. They came back as a collective to share the following: child obesity; community housing; unsafe drinking water, poverty, dental & vision coverage by OHIP, housing, healthy food, air pollution but not limited to traffic, community support for vulnerable groups, promotion of programs available for seniors, how messages are delivered regarding teen sexuality and diabetes.
- 5.2 The members felt strongly that they would like to keep their primary focus on poverty & food. Through the "dotmocracy" process the members narrowed down their priorities to housing, air pollution, dental and diabetes & obesity.
- 5.3 Factors that should be taken into account for setting advocacy include: impact of people, multiple effects, collaboration/ cooperation partnerships, targets results deadlines, diversity, evaluation and community engagement.
