(October 16, 2008) Report from Medical Officer of Health

Summary

Toronto Public Health's mission is to improve the health of the whole population and to reduce health inequalities. The attached report "The Unequal City: Income and Health Inequalities in Toronto 2008" measures health inequalities using Toronto data to describe a number of health indicators by income groups.

The report demonstrates that within Canada's largest city there are significant health inequalities. Areas of Toronto which have a greater proportion of people living with low income experience greater risk factors for illness, higher rates of disease, and death at an earlier age. For most of the health indicators, the data show that as low income is reduced, health improves. If everyone in Toronto was as healthy as those with the highest income and best health, there would be a significant improvement in the City's health overall.

Reduction of health inequalities will require inter-sectoral leadership within the City, engagement with community partners and advocacy for provincial and federal action. The information in this report will support efforts to better understand the relationship between income and health and to identify strategies that address inequalities and improve health for all in Toronto.

Cost of the Nutritious Food Basket - Toronto 2008

Decision Advice and Other Information

The Board of Health:

- 1. requested that the provincial and federal governments implement income support benefits and minimum wage rates based on the real cost of healthy living, including nutritious food, and indexed annually to reflect inflation;

Summary

This report provides information on the cost of the Nutritious Food Basket (NFB) in Toronto for 2008 and recommends measures to improve health through increased access to nutritious food for individuals and families living on low incomes in Toronto. The Nutritious Food Basket is a food costing tool used to measure the cost of a basic level of healthy eating in each Board of Health jurisdiction in Ontario.

The average weekly cost of basic nutritious food for a family of four in Toronto in 2008 is \$136.28 (\$590.09 per month). This is an increase of 2.4% over 2007. Over the last two years, the cost of the NFB has increased by approximately 9.4%.

The impact of rising food prices is more significant for low income people since they must allocate a greater portion of their income to purchase food. A family on social assistance or earning minimum wage requires approximately 30% of their income to purchase nutritious food, while a household that earns the median income for Ontario requires approximately 10% of their income to purchase nutritious food.

The provincial government has committed to developing a poverty reduction plan. Although the provincial government has taken several positive steps to help reduce poverty including the Ontario Child Benefit (OCB), announcing a 2% increase in social assistance rates in 2008, and increasing minimum wage to \$8.75/hour in March 2008, individuals and families living on social assistance or working at minimum wage still cannot afford shelter, nutritious food and other necessities required for good health.

The absence of effective action to correct this situation leaves the clear implication that malnutrition and poor health are acceptable consequences of official government policy.

Summary

Toronto Public Health undertook an environmental scan to gain a better understanding of the community-based participatory research projects that have been completed, are currently underway or are being planned in Toronto examining the health of racialized groups (including the impact of poverty). The purpose of this report is to provide a broad overview of the scan results to form the basis for a dialogue regarding further opportunities for collaboration and support in this area.

Community-based participatory research represents a rich and growing source of information, which has the potential to inform the development of programs and policies by communitybased organizations, Toronto Public Health, other city services, and different levels of government. It can identify the needs of community residents that have not been elucidated through other means. It is particularly useful when combined with other types of research as it provides a context for other data that are being generated.

Toronto Street Food Pilot

Decision Advice and Other Information

The Board of Health recommended to the Budget Committee and the Executive Committee that:

- 1. Toronto Public Health, in consultation with Legal Services and Municipal Licensing and Standards Division, implement a one year pilot project with eligible existing street food vendors to expand their menu selection to include healthier food choices, as described in Attachment A of this report;
- 2. Toronto Public Health, in consultation with Legal Services and Municipal Licensing and Standards Divisions, implement a three year "Toronto a la Cart" pilot project as described in Attachment B of this report;
- 3. new fees for the processing of applications, issuance of endorsements and annual license fees for the use of Toronto a la Cart vending locations be approved as set out in Attachment C of this report;

- 4. the "Toronto a la Cart" logo shown on Attachment D be approved as the official mark for the Pilot and any subsequent "Toronto a la Cart" program and staff be authorized to take the necessary actions to secure the exclusive rights for the City to protect and use this logo;
- 5. City Council accept the proposal from Crown Verity, originally submitted in response to the Request for Expressions of Interest No. 0616-08-7021 and authorize the agreement with Crown Verity on the terms described in the body of this report and Attachment E, and other terms as may be satisfactory to the Medical Officer of Health and the City Solicitor;
- 6. Toronto Public Health oversee the implementation and administration of the pilot projects and, in consultation with the City Manager's Office, provide future governance recommendations as part of the project evaluation;
- 7. all revenues associated with the pilot projects be directed to Toronto Public Health to offset costs;
- 8. the Toronto Public Health 2009 Operating Budget request be increased by \$86,000 gross and \$0.0 net, and a staff increase of 1.0 temporary position, to reflect required funding for the implementation of the Toronto Street Food pilot projects;
- 9. any year-end deficit resulting from the implementation of the Toronto a la Cart program be reported to the Budget Committee and funded from within Toronto Public Health's 2009 Operating Budget;
- 10. The Medical Officer of Health be delegated the authority for the term of the pilot project to make final decisions with respect to:
 - a. the processing of applications and issuance of endorsements to eligible existing street food vendors; and
 - b. the issuance of a request for applications document and award of agreements to selected Toronto a la Cart vendors,

and City Council retain no authority to act with respect to such matters;

11. City Council adopt the Terms of Reference as set out in Attachment F to this report, as amended by the Board of Health, and establish a Street Food Pilot Appeal Committee and delegate the authority to consider staff recommendations and make final decisions respecting the revocation of healthier food endorsements issued to existing vendors or termination of licence agreements with a Toronto a la Cart vendor for the term of the pilot project to the Board, and City Council retain no authority to act with respect to such matters;

- 12. Toronto Public Health be directed to further explore opportunities with food-related non-governmental organizations to test the feasibility of using street food vending to enhance their ability to achieve common goals and objectives and be directed to provide further pilot program details to the Board of Health at a later date;
- 13. the Medical Officer of Health, in consultation with the City Solicitor be authorized to report to the next Executive Committee respecting any necessary amendments to City by-laws and the Municipal Code as required to implement and regulate the operation of the pilot projects as proposed in this report; and
- 14. the Medical Officer of Health provide recommendations on an annual basis, beginning in the fall of 2009, with respect to the status of the Toronto a la Cart pilot project.

Summary

Changes to Regulation 562 of the Health Protection and Promotion Act in 2007 enable street food vendors to sell a wider variety of food items from street food vending carts. This report outlines a three stream approach to testing the impact of broadening healthier food choices available in the City from street food vendors to maximize the potential benefits from this regulatory change. The report requests authority to implement a 2009 pilot project to expand the menus of the existing street food vendors. It requests a spring 2009 pilot launch of the Toronto a la Cart program for new vendors at selected locations on City property to offer culturally diverse, nutritious menus. This report requests authority to enter into an agreement with the respondent of the previously released Request for Expressions of Interest for the production of food carts. It further outlines a future third opportunity to engage in partnerships with external food-related Non-Governmental Organizations to explore the use of street food vending to achieve common goals.

To ensure sufficient lead time for cart manufacturing and spring 2009 launch, City Council approval must be given by December 2008.
