

## **Parking Regulations: Wheelwright Crescent**

### **SUMMARY**

---

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with the City policy or by-laws.

To obtain approval to prohibit parking on the outer perimeter of Wheelwright Crescent, from Hullmar Drive (west leg) to Hullmar Drive (east leg).

The installation of the parking prohibitions will address the residents' concerns regarding the overnight parking activity on Wheelwright Crescent.

### **RECOMMENDATIONS**

---

Transportation Services Division, North York District, recommends that:

1. Schedule VIII of By-law No. 31001, of the former City of North York, be amended to prohibit parking from 12:00 a.m. to 6:00 a.m., on the west/south/east side of Wheelwright Crescent, from Hullmar Drive (west leg) to Hullmar Drive (east leg).

### **FINANCIAL IMPACT**

All costs associated with amendments to the parking regulations on Wheelwright Crescent are included within the Transportation Services Division's 2008 Operating Budget.

## **ISSUE BACKGROUND**

Transportation Services Division, North York District, was requested by Councillor Anthony Perruzza, on behalf of residents of Wheelwright Crescent, to review the feasibility of prohibiting overnight parking on Wheelwright Crescent.

## **COMMENTS**

The residents of Wheelwright Crescent have indicated that the residents of the neighbouring apartments on the adjacent roadways are continually parking overnight on Wheelwright Crescent.

Currently, parking is prohibited at anytime on the inner perimeter of Wheelwright Crescent, from Hullmar Drive (west leg) to Hullmar Drive (east leg) and three hour parking is permitted on the outer perimeter of the roadway. The overnight Winter Maintenance By-law is also in effect prohibiting parking from 2:00 a.m. to 6:00 a.m., from December 1<sup>st</sup> to March 31<sup>st</sup> of each year.

The Councillor's office has petitioned the affected residents and the majority of the residents are in favour of amending the parking regulations on Wheelwright Crescent in order to prohibit parking on the outer perimeter of the roadway from midnight to 6:00 a.m.. We are in support of the proposed extension of the parking prohibitions on the outer perimeter of Wheelwright Crescent.

Councillor Perruzza has indicated his support to amend the parking regulations as per the residents' request.
