

Parking Regulations: Luverne Avenue, Champlain Boulevard to Delahaye Street

SUMMARY

This staff report is about a matter that the Community Council has delegated authority to make a final decision, provided that it is not amended so that it varies with City policy or by-laws.

To obtain approval to amend parking prohibitions on the south side of Luverne Avenue, from Champlain Boulevard to Delahaye Street.

The introduction of the proposed parking prohibitions will address residents' concerns regarding parking on both sides of Luverne Avenue during the daytime hours from Monday to Friday.

RECOMMENDATIONS

Transportation Services Division, North York District recommends that:

1. Schedule VIII of By-law No. 31001, of the former City of North York, be amended to delete the "No Parking, 8:00 a.m. to 6:00 p.m., Monday to Friday" prohibition on both sides of Luverne Avenue, from the westerly limit of Laurentia Crescent to the easterly limit of Champlain Boulevard;

2. Schedule VIII of By-law No. 31001, of the former City of North York, be amended to delete the “No Parking, 7:00 a.m. to 10:00 a.m., Monday to Friday” prohibition on the south side of Luverne Avenue, from the westerly limit of Laurentia Crescent to the easterly limit of Champlain Boulevard;
3. Schedule VIII of By-law No. 31001, of the former City of North York, be amended to prohibit parking from 8:00 a.m. to 6:00 p.m., Monday to Friday on both sides of Luverne Avenue, from Champlain Boulevard to Delahaye Street; and
4. Schedule VIII of By-law No. 31001, of the former City of North York, be amended to prohibit parking from 7:00 a.m. to 10:00 a.m., Monday to Friday on the south side of Luverne Avenue, from Delahaye Street to Laurentia Crescent

FINANCIAL IMPACT

All costs associated with the amendments of the parking regulations are included within the Transportation Services Division’s 2008 Operating Budget.

ISSUE BACKGROUND

Transportation Services, North York District, was requested by Councillor Michael Feldman, on behalf of the residents of Luverne Avenue, between Champlain Boulevard and Delahaye Street to review the feasibility of prohibiting parking on the south side of the roadway between 8:00 a.m. and 6:00 p.m., Monday to Friday.

The residents of the roadway have indicated that commuters are parking on Luverne Avenue, from Champlain Boulevard to Delahaye Street and then walking to the Wilson Subway Station.

COMMENTS

Currently, parking is prohibited from 8:00 a.m. to 6:00 p.m., Monday to Friday on the north side and from 7:00 a.m. to 10:00 a.m., Monday to Friday on the south side of Luverne Avenue, from Champlain Boulevard to Laurentia Crescent.

Laurentia Crescent is a local roadway with a width of 8.5 metres and no municipal sidewalks on either side. The entire roadway is comprised of single family residential homes with adequate on-site parking to accommodate the residents of the homes. Laurentia Crescent is approximately 400 metres from the Wilson Subway Station.

An on-site review by staff has indicated that at any given time after 10:00 a.m., several vehicles can be found parked on the roadway in excess of the three-hour limit.

Councillor Michael Feldman has undertaken a survey of the residents of the roadway and the majority have indicated that they are in support of prohibiting parking on both sides of Luverne Avenue, from Champlain Boulevard Delahaye Street from 8:00 a.m. to 6:00 p.m., Monday to Friday.

In view of the results of the survey and since the installation of the proposed parking amendments would not adversely affect the residents, this division would not have any objection to amending the parking prohibitions as requested.

Councillor Michael Feldman supports the recommendations of this staff report.
