7.2.2 Gibson House Museum (David Gibson's House, Ward 23)

The Chair reported that she received a call from Katy Peplinskie, Associate Editor of City Magazines, regarding the development status at the Gibson House Museum site. She answered some questions and suggested that Ms. Peplinskie contact the local Councillor and the Developer's representative (George Belza, Analogica). A copy of the resulting article, *Threat to Gibson House has passed* from the *Bayview Post*, was circulated.

2008-1-5 939 Lawrence Avenue East (Shops on Don Mills) Ward 25: street names

On December 17, 2007 a meeting was held at Heritage Toronto, attended by Wendy Greenwood, Director of Marketing, Ontario Portfolio, Cadillac Fairview; Gary Miedema, Plaques & Markers Program, and Peggy Mooney, Executive Director, Heritage Toronto; Douglas Campbell and Edith Geduld, North York Community Preservation Panel. Following review and discussion, it was agreed that instead of 12 plaques on the commercial buildings, perhaps 2 plaques could be installed that recognize heritage people, industrial development and the Don Mills story.

Moved by M.A. Cross, seconded by A. Grenzebach, that a committee, consisting of Doug Campbell, Karl Frank and Edith Geduld, be formed to work on the plaquing project and consult with the Badone and Jeanne Hopkins. Carried.
