### ITEM DISCUSSED

### 2008.1.1 Appointment of Treasurer

## 2008.1.9 **Up-to-Date List and Maps Indicating Listed/Designated Properties** The Chair will contact P. Maka for updated lists and maps. Each Panel member will receive information on their assigned Ward.

### 2008.1.10 Naming of Public Lanes in Ward 28 (Phase 1 of 5)

Doug McTaggart from the Cabbagetown Preservation Association provided background information and answered questions regarding the 13 suggested lane names - "Doctor O Lane", "Silkweed Lane", "Nuthatch Lane", "Catbird Lane", "Woodward Evans Lane",

"Hagan Lane", "Calgie Lane", "Drovers Lane", "Verner Lane", "Callaghan Lane", "Heads Lane", "Windeyer Lane", and "Nighthawk Lane". The Panel members found the suggested names acceptable.

- 2008.1.11 **Naming of Public Lane West of Yonge St, South of Wellesley St W (Ward 27)** The Panel members found the suggested name of "St. Luke Lane" acceptable. The suggested name is in recognition of St. Luke's Church that stood nearby on Bay Street prior to 1930. Sometime in the 1930's, the church was demolished.
- 2008.1.12 **Renaming of Portion of Duncan Street to "Ed MirvishWay" (Ward 19, 20)** The Panel members found the naming of the parkette and the recognition signs acceptable but decided to defer the renaming of portion of Duncan Street to next meeting. The Chair felt further research necessary regarding Duncan Street history and its significance.

### 2008.1.13 Heritage Conservation District (HCD) Suggestions

Recently Heritage Preservation Services has engaged a Ryerson Planning School Studio class to map potential heritage conservation districts across the city. As part of this exercise they are conducting research, investigating neighbourhoods, histories, grid anomalies and collecting suggestions.

S. Barrett and C. Chan, a Ryerson student, attended the meeting in order to hear the Panel members' suggestions for potential HCDs within their district.

Some questions asked were:

Are there neighbourhoods with a consistent character or important history that might warrant an HCD?

Will further study of a neighbourhood reveal historic trends or patterning that might warrant protection through designation?

Is there a residential area with a historic character that staff has yet to evaluate? Is there a commercial area with a historic character that staff has yet to evaluate? What neighbourhoods strike you as unique, special, historic or possessing a unique or special character? How is that quality embodied in the area? Does it have historical importance or impact?

Some suggestions by Panel members were: Annex, Queen Street E, Don Mills, Palmerston, Beaconsfield Village, Ossington, railway corridors, Roncesvalles, Parkdale, Davisville and Leaside.

All Panel members (especially those not present) were asked to submit any other suggestions to the Chair within a week in order to be submitted to S. Barrett.

### 2008.1.14 Historical Societies and Residential Associations

All Panel members were asked to compile a list of Historical Societies and Residential Associations (for example, Bay Corridor Community Association or Cabbagetown Preservation Association) to be contacted. The list will be discussed at the next meeting and divided among members and their Wards.

### 2008.1.15 Newsletter Subscriptions and Memberships

Deferred to next meeting. The Panel members will discuss which subscriptions and memberships to renew (for example, Toronto Historical Association Newsletter, Built Heritage News, The Fife and Drum, Community Heritage Ontario, Toronto Architectural Conservancy, Ontario Heritage Connection).

### 2008.1.16 **Demolition Review**

The Chair will forward a list of demolition permits that Heritage Preservation Services has reviewed. These will be sent for information and review (divided among members and their Wards). If any of the properties are on the Heritage Inventory it will be noted on the list. The intention is that the Panel members will know where development is happening and can identify areas that they may want to make a priority for future listings.

### 2008.1.18 Suggested Buildings to List or Designate

Deferred to next meeting. The Panel members will bring forth building(s) they deem worth listing or designating. Buildings/areas discussed at prior meeting were: Fort York Armoury, Toronto Community Housing Corporation properties, churches, commercial areas such as Parliament, Roncesvalles, Yonge, Ossington, and Queen West.
