SUMMARY

From time to time, technical or typographical errors in various entries in the City’s traffic and parking by-laws are identified or brought to the attention of staff. These are compiled and periodically submitted for Committee and Council approval to ensure the accuracy of the by-laws. The purpose of this report is to effect such housekeeping amendments to correct technical or typographical errors or omissions in Schedule I to Municipal Code Chapter 910, Parking Machines and to confirm the authority for by-law 872-2007, which made changes to the schedule of Chapter 910. This report will ensure the continued accuracy and enforceability of the by-law. None of the amendments set out in the report will result in changes to signage or regulations in the field.

RECOMMENDATIONS

The Toronto Parking Authority recommends that:

- (1) the changes, additions and deletions to Schedule I of Municipal Code Chapter 910, Parking Machines, as set out in Schedule “A” to this report be adopted;
- (2) By-law No. 872-2007 be ratified and authorized as of the date of its passing; and
- (3) the appropriate City officials be requested to take any action necessary to give effect to the foregoing, including the introduction in Council of any Bills that may be required.

Financial Impact

The amendments contained in this report are housekeeping in nature and will not result in any expenditure of funds.

DECISION HISTORY

At its meeting of May 23, 24, and 25, 2007, City Council adopted report Planning and Growth Management Committee Item 4.6 and subsequently passed by-law 872-2007 on July 19, 2007 in order to make adjustments to the on-street parking rates and rate zones for parking areas under the authority of the Toronto Parking Authority.

COMMENTS

A review of Schedule I to Municipal Code Chapter 910 revealed a number of entries which are incorrect or which had been inadvertently omitted and which should be amended, deleted or inserted.

The amendments identified in the Appendices to this report are housekeeping in nature and are required in order to correct typographical/clerical errors or omissions and to ensure that the schedule conforms with the by-laws and reports previously adopted by Council. None of the amendments will result in any new or changed regulations or requirements in relation to on-street parking administered by the Toronto Parking Authority.

Further, when approving Report Planning and Growth Management Committee Item 4.6, Council authorised changes to parking meter rates, adjustments to parking meter zone boundaries and changes in maximum parking durations for on-street metered locations. Although the recommendations in Planning and Growth Management Committee Item 4.6 referenced only parking meters, it is clear that the intent of the Toronto Parking Authority and Council was to make the adjustments to parking rates, zone boundaries and maximum parking durations for all on-street meters and machine locations. This is evidenced by the supporting documentation appended to the report. By-law 872-2007 implemented these adjustments.
