SUMMARY

This is a supplementary report to a report (August 20, 2008) currently before Planning and Growth Management Committee regarding a proposed Official Plan Amendment (OPA) to authorize Section 37 funding of Heritage Conservation District (HCD) studies as an eligible Section 37 benefit. Minor revisions are required to a schedule and maps that form part of the proposed Official Plan Amendment attached as Appendix A to that report. The effect of these revisions is to eliminate one Potential HCD and merge two others to form one.

This report recommends that the attached revised Schedule A and Map Nos. 5 and 6 be substituted for the originals in Appendix A to the August 20, 2008 report.

RECOMMENDATIONS

The City Planning Division recommends that:

1. The revised Schedule A and revised Maps 5 and 6 attached to this report be substituted for the original Schedule A and Maps 5 and 6, respectively, as contained in the proposed Official Plan Amendment attached as Appendix A to the report dated August 20, 2008 to Planning and Growth Management Committee from the Chief Planner and Executive Director, City Planning, and entitled "Revised Official Plan Amendment to Authorize Section 37 Funding of Heritage Conservation District Studies as an Eligible Community Benefit".

Financial Impact

The recommendations of this report will have no financial impact.

DECISION HISTORY

See under separate cover the original report dated August 20, 2008 from the Chief Planner and Executive Director, City Planning Division, on this subject.

ISSUE BACKGROUND

The original report dated August 20, 2008 from Chief Planner and Executive Director, City Planning Division, has been prepared at Council's direction, recommending certain amendments to the Official Plan to authorize funding of HCD studies as an eligible Section 37 community benefit under specified conditions. Minor revisions to the proposed Official Plan Amendment (OPA) are recommended in this supplementary report.

COMMENTS

Need for a Supplementary Report

Necessary minor revisions to the proposed Official Plan Amendment were identified prior to the Committee reporting deadline, but too late for the revisions to be included on the maps forming part of the statutory notice to be published in a newspaper on August 20, 2008. Legal staff advised that these minor revisions do not require a further statutory notice. Legal staff advised that the maps attached in the August 20, 2008 report should reflect the same information as contained in the notice maps. Therefore, the minor revisions are conveyed to Committee by way of this supplementary report.

Recommended Revisions to Proposed OPA

The recommended revisions to the proposed OPA are as follows:

1. Potential Heritage Conservation District (HCD) No. F, Glen Edyth

This area labelled as "F" is shown on the proposed Map 5 in the proposed OPA as a Potential HCD "Authorized For Study as of July 2008". The geographic area is authorized for study, but as part of the abutting Potential HCD No. D, Casa Loma. The minor map revision is to eliminate on Map 5 the label "F" and the dividing line between Potential HCD Nos. D and F. The result will be that the geographical area formerly labelled as "F" then merges with, and forms part of, Potential HCD No. D, Casa Loma.

Since Potential HCD No. F (the label, not the geographical area) is being eliminated on the map, it must also be deleted from Schedule A to the proposed OPA, being the list of Potential Heritage Conservation Districts. The numbering of other Potential HCDs will not be changed; there will simply be no Potential HCD in the list or on the maps with the label "F".

2. Potential HCD No. I, Riverdale Area Phase 1

At the July 15 and 16, 2008 Council meeting, Council expressed an intention to designate Potential HCD No. I as an HCD. The HCD studies for this area have previously been completed. Therefore, the area should no longer be considered a "Potential" HCD study area. Both the label "I" and the related geographical area should be removed from Map 6 and the number and name should be removed from Schedule A. Once the geographical area is removed, that area will no longer have any shading. The numbering of the remaining Potential HCDs in Schedule A will not change.

Schedule A and Maps 5 and 6, revised in accordance with the above discussion, are attached to this report. This report recommends that these revised documents replace those contained in the Proposed OPA attached as Appendix A to the report dated August 20, 2008.
