Harmonized Sign By-law Interim Report - Revised

Decision Advice and Other Information

The Planning and Growth Management Committee:

- a. requested the Chief Building Official to consider the submissions received at this Special Meeting while conducting the second series of public consultation sessions, and submit a second interim report prior to going forward with a draft by-law on the Harmonized Sign By-law; and
- b. referred the following motions to the Chief Building Official and Executive Director of Toronto Building for consideration and report to the Committee:

That the Chief Building Official and Executive Director of Toronto Building report to the Committee on the following:

(Motion by Councillor Vaughan)

1. how identified Heritage Districts could constitute stand alone zones or districts;
2. guidelines governing political advertising to ensure fair and balanced access to display area;

3. revenues, penalties and how rates could be used to finance proposed changes;
4. an approval and appeal process that sustains Community Council as the body of final decision;
5. include environmental guidelines that require electronic signs to either self generate electricity as part of the sign or allow for off site offsets;
6. how MPAC currently assesses signs and billboards and on what impact a standardized tax classification might have on city revenues.

7. specific and clear identification of any new recommendations for as-of-right permissions to erect signs;
8. staff develop a policy on the donation of community benefits by sign companies;
9. significant attempts be made to have meaningful consultation with residents and Councillors;
10. the character of the distinctive areas and the wishes of residents be noted and respected;
11. construction hoarding be treated as advertising where it functions as a billboard advertising a product, and further, consideration be given to charging a fee;
12. if the delegation of 1st party signs to staff is recommended, that these be accredited by consultation with Councillors and a bump-up provision;
13. consider a notification process for residents for any large sign variance applications;
14. companies which have illegal signs 30 days after enactment of the new Sign By-law not be granted a licence to operate in the City of Toronto; and
15. provide the Committee with information on the number of illegal signs in the City of Toronto and the companies involved.

(December 3, 2008) Report from Chief Building Official and Executive Director

Summary

This report replaces the report dated November 26, 2008 from the Chief Building Official and Executive Director.

This report describes the progress made following the first stage of public and stakeholder

consultation respecting the City's harmonized sign by-law. The sign by-law project team has been directed to bring forward progress reports at critical stages through the Chief Building Official and Executive Director, Toronto Building.

Through the first stage of the project, key issues that need to be addressed have been identified. The issues can be categorized into two distinct units - Organizational and Process Issues (dealing with internal matters relating to policy, procedure and staffing) and Substantive Sign Issues (dealing with external matters relating to environment, technology and sign proliferation).

Martin Rendl of the Planning firm Martin Rendl Associates, the sign study consultant, will present, in detail, the key issues at this Special Meeting of the Planning and Growth Management Committee.
