St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road – Road alterations and traffic regulations for the St. Clair Avenue West Transit Improvement Project

SUMMARY

Transportation Services is seeking authority to introduce road alteration by-laws and amendments to traffic regulations on St. Clair Avenue West, from Westmount Avenue to Vaughan Road, to allow for the construction and implementation of the St. Clair Avenue West Transit Improvement Project as approved by City Council.

RECOMMENDATIONS

Transportation Services recommends that:

1. City Council authorize the preparation of a by-law for the alteration of St. Clair Avenue West, between Westmount Avenue and Vaughan Road, to allow construction of the Preferred Design Concept identified through the St. Clair Avenue West Transit Improvements Class Environmental Assessment study process. The modifications, generally as shown on Drawing Nos. 421F-9227, 421F-9228, 421F-9229, 421F-9230, 421F-9231, EY08-58, EY08-59, EY08-60, EY08-61 and EY08-62, dated March 2008, include:
 - a. construction of a raised, mountable trackbed in the centre of St. Clair Avenue West, between signalized intersections, for the exclusive use of public transit vehicles and emergency service vehicles, including Police, Fire, and Emergency Medical Services;

- b. removal of all existing streetcar platforms and replacement with new, wider farside platforms on the north side of St. Clair Avenue West, west of Northcliffe Boulevard, west of Glenholme Avenue, east of Oakwood Avenue, west of Winona Drive, west of Arlington Avenue, west of Christie Street, and west of Wychwood Avenue; and on the south side of St. Clair Avenue West, east of Northcliffe Boulevard, east of Glenholme Avenue, east of Oakwood Avenue, east of Winona Drive, east of Arlington Avenue, east of Christie Street, and east of Wychwood Avenue;
 - c. widening the pavement, up to 1.8 metres, on the north and south sides of St. Clair Avenue West, at Northcliffe Boulevard, at Glenholme Avenue, at Oakwood Avenue, at Alberta Avenue, at Winona Drive, at Arlington Avenue, at Christie Street, and at Wychwood Avenue; and
 - d. narrowing the pavement up to 2.1 metres, on St. Clair Avenue West, at Lauder Avenue (northeast and southwest corners), at Glenholme Avenue (northeast and southeast corners), at Appleton Avenue (northeast corner), at Crang Avenue (northwest corner), at Rushton Road (northwest corner), at Pinewood Avenue (northwest corner) and at Wychwood Avenue (northwest, southwest and southeast corners).
2. City Council rescind the existing parking regulations on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “A”.
 3. City Council enact the proposed parking regulations on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “B”.
 4. City Council rescind the existing turn prohibitions on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “C”.
 5. City Council enact the proposed turn prohibitions and compulsory turns on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “D”.
 6. City Council rescind the existing reserved lane designations on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “E”.
 7. City Council enact the proposed reserved lane designations on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “F”.

8. City Council enact the proposed one-way traffic lanes on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “G”.
9. City Council rescind the existing streetcar loading platforms on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “H”.
10. City Council enact the proposed streetcar loading platforms on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, listed in the attached Appendix “I”.
11. City Council approve the installation of traffic control signals at the intersection of St. Clair Avenue and Alberta Avenue as identified through the St. Clair Avenue West Transit Improvements Class Environmental Assessment study process, generally as shown in Drawing No. EY08-62, dated March 2008.

Financial Impact

All costs associated with the road alterations and traffic regulation changes have been included for funding as part of the St. Clair Avenue West Transit Improvement Project.

DECISION HISTORY

City Council, at its meeting of September 28, 29, and 30 and October 1, 2004, adopted, as amended, Clause No.1 of the Policy and Finance Committee Report No. 7, entitled “St. Clair Avenue West Transit Improvement Environmental Assessment – Yonge Street to Gunns Road (Just West of Keele Street) (St. Paul’s, Davenport, York South-Weston).”

ISSUE BACKGROUND

The above-noted report, among other things, approved the Preferred Design Concept identified through the St. Clair Avenue West Transit Improvements Class Environmental Assessment study process, the principal elements of which are as follows:

- two centre lanes reserved for exclusive use by streetcars (and emergency vehicles) protected by a raised, but mountable trackbed;
- during peak periods, two general purpose traffic lanes in each direction, located on either side of the streetcar tracks, providing sufficient capacity to accommodate all current peak period traffic volumes on St. Clair Avenue West;
- during off-peak periods and weekends, one general purpose traffic lane and one parking lane in each direction providing sufficient capacity to accommodate all current off-peak and weekend traffic volumes;
- left-turn lanes at signalized intersections to permit left-turns and U-turns on their own exclusive signal phase;

- on-street parking on both sides of the street during off-peak times on weekdays and at all times on weekends to be permitted in the majority of the curb lanes, and new off-street parking, resulting in a net increase in the parking supply along St. Clair Avenue West; and
- enhanced streetscape, urban design, streetcar shelters and platforms, public art and safety features in the overall design and implementation of the transit improvements project.

Also contained within the approved recommendations was a recommendation that “approval be granted in principle for the traffic by-laws required to implement this project...”(Recommendation (8) contained within the report from the Commissioner of Urban Development Services, the Acting Commissioner of Works and Emergency Services, the Chief General Manager of the Toronto Transit Commission, (TTC) and the President, Toronto Parking Authority, dated August 31, 2004).

COMMENTS

Construction of the transit improvements on St. Clair Avenue West between the streetcar loop at the St. Clair subway station east of Yonge Street and a point approximately 40 metres west of Vaughan Road has been completed. The 2008 portion of this project will include the completion of Phase 2 that commenced in 2007 on the segment between Caledonia Road/Caledonia Park Road and Westmount Avenue. The road alteration by-laws on this section of St. Clair Avenue West were approved by Council on July 16, 17, 18 and 19, 2007.

In Phase 3, the portion scheduled for construction commencing 2008 is from a point 40 metres west of Vaughan Road to Westmount Avenue. St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Winona Drive is located in the Etobicoke York Community Council area. The section between Winona Drive and a point 40 metres west of Vaughan Road is located in the Toronto and East York Community Council area.

With the majority of the detailed design work complete for this phase, it is now possible to provide the details for preparation of the required road alteration by-laws. Also, Transportation Services undertook a review of the existing traffic and parking-related by-laws on this section of St. Clair Avenue West so that the appropriate amendments can be made for the St. Clair Avenue West Transit Improvement project.

Road Alterations

The necessary road alterations are detailed in Drawing Nos. EY08-58 to EY08-62, dated March 2008 (Etobicoke York Community Council area), and in Drawing Nos. 421F-9227 to 421F-9231, dated March 2008 (Toronto and East York Community Council area), attached to this report. They include:

- a raised mountable trackbed in the centre of St. Clair Avenue West, between the signalized intersections. This raised trackbed will be reserved for TTC transit vehicles and emergency services vehicles only;

- wider, far-side platforms at signalized intersections along this section of St. Clair Avenue West. This involves relocation of the existing nearside platforms or reconstruction of existing far-side platforms;
- pavement widening at select locations within the vicinity of the signalized intersections. These widenings are required to accommodate the track allowance and platforms, and the left-turn/U-turn lane and two through lanes of minimum width for each direction approaching the intersection. No widenings are proposed between intersections; and
- pavement narrowings on St. Clair Avenue West at Lauder Avenue, Glenholme Avenue, Appleton Avenue, Crang Avenue, Rushton Road, Pinewood Avenue and at Wychwood Avenue.

Parking Regulations

The attached Drawing Nos. EY08-78 to EY08-81, dated March 2008 and Drawing Nos. 421F-9219 and 421F-9232, dated March 2008 show the existing (Appendix “A”) and proposed parking regulations (Appendix “B”), respectively, for St. Clair Avenue West between Caledonia Road/Caledonia Park Road and Vaughan Road.

Generally, parking is prohibited on the south side of St. Clair Avenue West, between Caledonia Road and Winona Drive, from 7:00 a.m. to 9:00 a.m., Monday to Friday. On the north side of the street, parking is allowed for a maximum period of one hour, from 8:00 a.m. to 6:00 p.m., Monday to Saturday.

Currently, on the north side of St. Clair Avenue West, between Winona Drive and Vaughan Road, on-street parking is generally allowed at all times. On the south side parking is allowed outside of the weekday morning peak period (7:00 a.m. to 9:00 a.m. Monday to Friday).

In addition, on both sides of the street, stopping is prohibited adjacent to the streetcar platforms and parking is prohibited in the immediate vicinity of intersections (Appendix “A”).

The proposed regulations, for this section of St. Clair Avenue West, generally consist of stopping prohibitions for both directions during the morning and afternoon peak periods, and stopping prohibitions adjacent to the streetcar platforms and within 30.5 meters of the signalized intersections. The stopping prohibitions are required to ensure that two vehicle lanes are available in each direction during the peak periods and at all times at the intersections. On-street parking is maintained during the off-peak hours and on weekends (Appendix “B”). In the Etobicoke York Community Council area the number of existing on-street parking spaces is 260 and approximately 265 parking spaces will be provided with the proposed plan. In the Toronto and East York Community Council area the number of existing on-street parking spaces will be maintained at approximately 115 with the proposed plan. Taxicab stands are provided on the north and south sides of St. Clair Avenue West, between Dufferin Street and Westmount Avenue, Lauder Avenue and Glenholme Avenue, and between Rushton Road and Humewood Drive. These taxicab stands will be maintained in their current locations, but will not operate during

the weekday peak periods. Additionally, a number of parking meter and parking for restricted periods by-laws are outdated and should be rescinded as per Appendix “A”.

Turn Prohibitions, Reserved Lanes and One-way Traffic Lanes

The Preferred Design Concept for St. Clair Avenue West includes two centre lanes reserved for exclusive use by streetcars (and emergency vehicles) protected by a raised, but mountable, trackbed. Turning or through movements across the streetcar tracks will only be possible at signalized intersections, where the trackbed will be at grade with the roadway. It is therefore necessary to prohibit left-turn and through movements from all sidestreets, laneways and driveways that intersect St. Clair Avenue but are not controlled by traffic signals. U-turns will also be prohibited in both directions of St. Clair Avenue West between all signalized intersections (Appendix “D”).

To match the current field conditions the by-law that prohibits westbound left-turns at St. Clair Avenue West and Vaughan Road should be updated to exempt TTC vehicles. Also, the by-laws should be updated for the westbound right-turn-on-red prohibition that is currently signed but not by-lawed on St. Clair Avenue West at Vaughan Road.

Additionally, the northbound approach on Vaughan Road at St. Clair Avenue West is comprised of two lanes. The curb lane is marked for right turns only and the median lane is marked for through and left turns only with advisory signs. To improve traffic operations these two lanes should be by-lawed and signed with regulatory signs (Appendix “G”). The summary of existing turn prohibitions (Appendix “C”) and the proposed turn prohibitions (Appendix “D”) are attached to this report.

Also, it is necessary to designate the two centre lanes for public transit vehicles (PTVs) and emergency service vehicles only for the full length of St. Clair Avenue West between Caledonia Road/Caledonia Park Road and Vaughan Road (Appendix “F”). Currently, the centre lane with the streetcar track is designated for left turns only; streetcars excepted approaching the intersection and is reserved for transit vehicles on the exit side of the intersection. These designations need to be rescinded (Appendices “E” and “F”).

Streetcar Loading Platforms

Streetcar loading platforms which are currently provided on the near side of the intersection will be relocated to the far side of the intersections (Appendices “H” and “I”). This will allow for improved transit service, and more efficient intersection operations. As well, far-side platforms minimize the pavement widening required at the intersections to allow for left-turn/U-turn storage lanes.

CONCLUSION

Approval of the recommendations for road alteration by-laws, and amendments to traffic and parking regulations on St. Clair Avenue West, between Caledonia Road/Caledonia Park Road and Vaughan Road, will allow for the construction and implementation of the next phase of the St. Clair Avenue West Transit Improvement Project as approved by City Council.
