#### **Extension to Leaf and Yard Waste/Christmas Tree Collection Programs**

(January 24, 2008) Report from the General Manager, Solid Waste Management Services.

#### Recommendations

The General Manager, Solid Waste Management Services, recommends that:

- 1. The current Leaf and Yard Waste and Christmas Tree collection schedules be amended beginning in September 2008, such that these services be provided on a bi-weekly basis with extended spring and fall Leaf and Yard Waste collection and extended Christmas tree collection.
- 2. The General Manager exercise his discretion to adjust the actual collection dates as required.

#### **Financial Impact**

The proposed amendments to the collection schedule are estimated to be cost neutral as the extended collection season will be offset by reduced collection frequency. Furthermore, the resources required are not expected to change. The recommended amendments to the collection schedule can be undertaken within the Recommended 2008 Operating Budget for Solid Waste Management Services.

The Deputy City Manager and Chief Financial Officer has reviewed this report and concurs with the financial impact statement.

#### Summary

The purpose of this report is to seek authority to amend the collection schedule for residential leaf and yard waste and Christmas tree collection programs.

This report recommends that the current seasonal programs be extended and the frequency of service be amended.

#### Extension of Green Lane Occupancy Licence and Transition Agreement and Trade-Mark Licence Agreement

#### F.G. Gardiner Expressway and Don Valley Parkway Closure - Heart and Stroke Foundation of Ontario - 2008, 2009 and 2010 "Ride for Heart" Event

#### Recommendations

Transportation Services recommends that City Council:

#### Update on the City's Accessible Pedestrian Signal (APS) Retrofit Program and an Ontario Human Rights Complaint Involving the City's Provision of APS

(January 21, 2008) Report from the City Solicitor and the General Manager, Transportation Services.

#### Recommendations

The City Solicitor and General Manager, Transportation Services recommend that:

- 1. Council adopt the confidential instructions to staff in Attachment 1.
- 2. City Council authorize the public release of the recommendation in Attachment 1 if a settlement to the Complaint is achieved in accordance with Council's instructions and in a form satisfactory to the City Solicitor.
- 3. All new traffic control signal installations approved by City Council, after the adoption of this report, include accessible pedestrian signals as an integral component of the intersection equipment and operation.
- 4. Transportation Services staff eliminate the existing backlog of 51 requested accessible pedestrian signal retrofit locations by December 31, 2010.
- 5. Funds totalling \$670,000 be transferred within the Transportation Services 2008 Approved Capital Budget from projects CTP708-03 Traffic Signal Modifications (\$335,000) and CTP707-07 Traffic Plant Requirements (\$335,000) to Capital project CTP708-06 Audible Signals to increase the \$680,000 included in the budget for the Accessible Pedestrian Signal Program (APS) improvements in 2008 to \$1,350,000 in order to address the backlog of intersections in 2008.
- 6. The General Manager, Transportation Services, be requested to revise the Transportation Services five-year Capital plan as part of the 2009 Capital Budget process to include the funds required to eliminate all of the remaining APS backlog in 2009 and 2010.
- 7. Commencing January 1, 2011, Transportation Services establish as a performance target and basis for Capital Budget requests, the retrofit and activation of an accessible pedestrian signal within 12 months of receipt of a request, assuming that no major physical intersection modifications are required.

#### **Financial Impact**

The addition of accessible pedestrian signal equipment to the installation of a new traffic control signal will add approximately \$10,000, or approximately seven percent to the cost of a new signal installation. Funding of new traffic control signals is provided within Capital Budget CTP708-01.

Funding for the retrofit of accessible pedestrian signal equipment to an existing traffic signal controlled intersection is included in CTP708-06. In 2007, the \$670,000 budget provided funding for the retrofitting of accessible pedestrians signals to 15 intersections. In order to achieve 81 retrofits in the next three years, an average of \$1,350,000 will need to be allocated annually to this program. For 2008, the required funding can be accommodated through funding of \$680,000 in CTP 708-06 Audible Signals approved in the 2008 Transportation Services Capital Budget and by reallocating cash flow in the amount of \$335,000 each from the approved cash flow of CTP 708-03 Traffic Signal Modifications and CTP 707-07 Traffic Plant Requirements to CTP 708-06 Audible Signals. Funding for this project is detailed in the table below:

#### 7a Snow Clearing Enforcement

(February 4, 2008) Memo from Councillor Joe Mihevc, Ward 21, St. Paul's West.

#### Summary

My office receives many complaints during the winter about the accumulation of snow and ice on City sidewalks, and the dangers this poses to pedestrians. Many of these complaints stem from the fact that business and home owners/managers neglect their responsibility to clear the municipal sidewalks in front of their property. Despite my office repeatedly informing residents of this responsibility, the problem persists. I suspect this is an issue each and every Councillor faces, thus warranting an enforcement and perhaps by-law review.

I urge the Public Works and Infrastructure Committee to request staff to report back to Committee and Council on strategies to strengthen and accelerate enforcement.

My own suggestions include:

- a. proactive enforcement;
- b. no warning letters, but issuances of tickets within 48 hours of a snowfall (thus increasing revenues that could be directed to enforcement); and
- c. use of crews to clean sidewalks, the cost of which is added to the offender's property tax.

#### Summary of Sewer Use By-law Compliance and Enforcement Activities

(February 4, 2008) Report from the General Manager, Toronto Water.

#### **Financial Impact**

There are no financial implications to the City as a result of this report.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.

#### Summary

The City of Toronto's Sewer Use By-law (Municipal Code Chapter 681 – Sewers) sets strict limits on heavy metals and toxic organic compounds in wastewater discharged to sanitary and storm sewers. It also has requirements for those industrial or commercial activities that may discharge any of the 38 subject pollutants identified in the By-law to submit Pollution Prevention (P2) Plans or comply with industry specific Best Management Practices (BMP). All these provisions are enforceable under the By-law. The maximum fine for a corporation who contravenes any provision of the By-law is \$100,000 and for every person other than a corporation the maximum fine is \$20,000.

Toronto Water has structured its monitoring and enforcement activities into four general programs. The programs are as follows:

- Routine Industrial Monitoring and Sampling Program;
- Industrial Waste Surcharge Agreement Program;
- Pollution Prevention (P2) Plan Program; and
- Stormwater Monitoring and Sampling Program.

In 2007, all of the monitoring and enforcement activities resulted in 4,418 inspections and 14,682 samples being collected that were analyzed by the Toronto Water Laboratory. Toronto Water enforcement action for non-compliance of the Sewer Use By-law resulted in the issuance of 418 written Notice of Violations (NOV), preparation of 26 prosecution cases, 17 of which are still before the courts and 9 concluded in convictions totalling \$49,000 in fines.

There were 135 active Industrial Waste Surcharge Agreements (IWSA) monitored by Toronto Water which generated \$7.1 million in revenue for the City in 2007.

Monitoring of industries for compliance with the Sewer Use By-law has established greater protection of sewer infrastructure, safer environments for staff working in the sewer system or wastewater treatment plants, reduced amount of contaminants into the wastewater stream that cannot be removed through current treatment plant processes and ensures biosolids meet the strict regulations set out by the Province in the Nutrient Management Act to allow application on agricultural land.

## Report on Over-Expenditure to Purchase Order No. 47012292 - Toronto Water Contract 07TE-301WS - Tender Call 218-2006

(January 18, 2008) Report from the General Manager, Toronto Water and the Director, Purchasing and Materials Management.

#### Recommendations

The General Manager, Toronto Water and the Director of Purchasing and Materials Managements Division recommend that:

- 1. Authority be granted to amend Purchase Order No. 47012292 for the emergency repair of water and sewer connections, mains and appurtenances in Toronto–East York District to OJCR Construction Ltd. by an additional amount of \$875,000.00 excluding GST, revising the current contract value from \$3,271,590.00 to \$4,146,590.00 excluding GST, representing an increase of 27%.
- 2. Council authorize and direct the appropriate staff to take the necessary steps to give effect thereto.

#### **Financial Impact**

The amendment for an additional \$875,000.00 excluding GST (\$918,750.00 with GST) increases the contract value with OJCR Construction Ltd. from \$3,271,591.00 excluding GST to \$4,146,590.00 excluding GST. #### **Financial Impact**

The total contract award identified in this report is \$5,375,743.35 including all applicable taxes and charges. The cost to the City net of GST is \$5,119,755.57. This project is included in the approved 2008 Toronto Water Capital Budget in WBS Element CWW045-01 Odour Control Upgrades - Phase One Engineering. However, at this time, the uncommitted cash flow is insufficient and additional cash flow authority is required to meet these commitments.

The funding approved for WBS Element CWW045-01 is \$2,050,000.00, net of GST and an additional \$3,069,755.57 is required in order to complete the engineering services for a total of \$5,119,755.57, net of GST. The cash flow requirements for this project are \$500,000.00 in 2008, \$1,000,000.00 in 2009, \$2,000,000.00 in 2010, \$1,500,000.00 in 2011 and \$119,755.57 in 2012 net of GST.

The engineering estimate for this project is \$2,050,000.00 net of GST. The estimate, however, did not include for the refurbishment of the electrical room in the headworks building and the engineering services related to modifications to the screening process. These two items were not previously identified in the odour study but were incorporated into the scope of work for this assignment. The refurbishment of the electrical room was identified by City staff as a requirement due to the risk of failure as a result of ageing and obsolete equipment, and non-compliance with existing electrical code. The modifications to the screening process were deemed necessary by City staff for successful implementation of the project, based on recent experiences in other wastewater facilities in the City.

The additional cash flow and project cost (all net of GST) is to be reallocated from approved 2008 capital projects (with net impact of \$0) as follows:
