Municipal Hazardous or Special Waste Funding from Waste Diversion Ontario/Stewardship Ontario

Financial Impact

The 2008 budgeted Contracted Hazardous Waste Removal (Cost Centre SW0612) is \$1,535,875.77. The 2008 projection for Hazardous Waste Removal is currently \$1.2 million based on year to date actuals. Preliminary estimates show that 35% of hazardous waste removal or \$420,000 per year could be funded by Stewardship Ontario for Phase 1 MHSW materials as defined by the MHSW Program Plan. Addition of New Blue Bin Materials

(June 11, 2008) Report from the General Manager, Solid Waste Management Services.

Financial Impact

Summary

This report summarizes the results of a Peer Review conducted on the draft Biosolids and Residuals Master Plan (BRMP) and details how the results will be incorporated into updating the Master Plan document.

The Peer Review sought to determine whether the decision-making model and scoring process used in the BRMP was appropriate. The Peer Review Panel concluded that the decision-making model used in the City of Toronto's BRMP was a reasonable model which is commonly used in master plans and environmental assessments but suggested some improvements to provide greater clarity to the Master Plan.

City staff have prepared a Terms of Reference to update and finalize the BRMP, taking into consideration the findings of the Peer Review Report and the changes that have occurred in the environment driving the considerations used in formulating the draft BRMP. UMA AECOM (formally KMK Consultants) will complete the work outlined under this Terms of Reference as part of the original BRMP project.

Options to Improve Enforcement and Reduce Instances of Illegal Dumping in the Rouge Park

(June 11, 2008) Report from the General Manager, Transportation Services and the Executive Director, Municipal Licensing and Standards.

Recommendations

The General Manager, Transportation Services Division and the Executive Director, Municipal Licensing and Standards Division recommend that:

- 1. The following be given consideration:
 - a. Eliminate lay-bys on Sewells Road which are currently being used as illegal dump sites by the installation of barrier-type devices.
 - b. Investigate the feasibility of implementing restrictions on stopping, standing and parking on Sewells Road and on Steeles Avenue East in the vicinity of Sewells Road and report to Scarborough Community Council.
 - c. Investigate the feasibility of permanently closing Littles Road and report back to Scarborough Community Council in six months with options for permanently closing this road.
 - d. Close Littles Road on a temporary basis by installing a gate to prevent unauthorized access to this roadway.
- 2. Locations be identified for the erection of new "No Dumping" signs to replace existing signs in areas of Rouge Park where illegal dumping occurs.

3. In consultation with the City Solicitor, Chapter 548 of the Toronto Municipal Code (Littering and Dumping of Refuse), the short form wordings, and set fines, be reviewed to identify those areas where it would be appropriate to raise the set fine from the current \$305.00, plus a victim fine surcharge, to the maximum of \$500.00.

Financial Impact

The financial cost of installing barrier-type devices on Sewells Road and the temporary gate on Littles Road is approximately \$85,000.00 (materials and installation). The cost of installing new signs in the Rouge Park area is approximately \$2,000.00 (materials and installation). Funding is available in the Transportation Services Operating Budget to accommodate these costs.

The financial cost of piloting the use of surveillance cameras in the Rouge Park is estimated to be in the range of \$50,000 (equipment, installation, maintenance and monitoring). Funding for this pilot program will be sought as part of the 2009 Budget process.

Summary

This report summarizes a number of options and associated financial costs that may be implemented to improve enforcement and reduce instances of illegal dumping in the area of the Rouge Park. Staff believe that permanent physical measures are necessary to reduce instances of illegal dumping in the Rouge Park area.

The majority of illegal dumping in the Rouge Park occurs on Sewells Road. There are a number of lay-bys on Sewells Road that provide the "opportunity" for vehicles to park and illegally dump materials on the side of the roadway. Staff are proposing that barrier-type devices be installed to remove the lay-bys which are presently being used to facilitate illegal dumping.

Staff are also investigating the feasibility of permanently closing Littles Road to a point approximately 700 metres south of Steeles Avenue, East. Permanent closure of this road will deny those responsible for illegal dumping the "opportunity" in this area. In the short term, or until it is feasible to permanently close Littles Road, staff are proposing the temporary closure of this road by installing a gate to prevent unauthorized public access to this road.

Recognizing that permanent changes take time to implement, there are a number of options available to improve enforcement, which, if implemented in a co-ordinated manner by Transportation Services and Municipal Licensing & Standards (ML&S) Division could reduce instances of illegal dumping in this area until such time as more permanent measures are implemented. Temporary enforcement activities which can be used to address illegal dumping in the Rouge Park include:

- piloting the use of surveillance cameras;
- increasing the presence of the City By-law Enforcement Officers;
- updating the existing signage with new "No Dumping" signs;
- promoting a community awareness/reward program; and
- reviewing Chapter 548 of the Toronto Municipal Code (Littering and Dumping of Refuse).

2008 Bikeway Network Program - Phase 3 Installation of Bicycle Lanes

(June 11, 2008) Report from the General Manager, Transportation Services.

Recommendations

The General Manager, Transportation Services recommends that:

- 1. City Council approve the installation of a westbound contra-flow bicycle lane on the north side of Stanley Avenue from Royal York to Superior Avenue, as detailed in Appendix A of this report.
- 2. City Council approve the installation of bicycle lanes on the west side of Royal York Road, from Cavell Avenue to Evans Avenue, and on the east side of Royal York Road from Cavell Avenue to Manitoba Street, as detailed in Appendix A of this report.
- 3. City Council approve the installation of bicycle lanes on both sides of Simcoe Street/Lower Simcoe Street, from Queens Quay West to Front Street West, as detailed in Appendix A of this report.
- 4. City Council approve the installation of stop control for eastbound, westbound, northbound and southbound traffic at the intersection of Bremner Boulevard and Simcoe Street/Lower Simcoe Street.
- 5. Subject to budget availability, City Council approve the installation of traffic control signals at the intersection of Bremner Boulevard and Simcoe Street/Lower Simcoe Street, and in conjunction, remove the stop control by-laws for this intersection.
- 6. City Council approve the installation of bicycle lanes on both sides of Birchmount Road, from Kingston Road to a point 65 metres south of St. Clair Avenue East, as detailed in Appendix A of this report.
- 7. City Council approve the amendments to the traffic and parking regulations detailed in Appendix B of this report.
- 8. City Council authorize and direct the appropriate City officials to take the necessary action to give effect thereto, including the introduction of all necessary bills.

Financial Impact

Funds to implement the bicycle lanes contained in this report are provided for within the Transportation Services Division 2008 Capital Budget in the Cycling Infrastructure Account CTP 808-05.

The estimated cost for installing traffic control signals at the intersection of Bremner Boulevard and Simcoe Street/Lower Simcoe Street will be approximately \$140,000.00, including application of pavement markings and removal of existing signs. Funds for the installation of

new traffic control signals are contained in the Transportation Services Capital Program requests under Project No. CTP708-01. In 2008, \$1.94 million has been approved for new traffic control signal installations. Installation of traffic control signals at this location will be subject to availability of funds and similar competing priorities. The added annual operating and maintenance costs associated with this installation are \$5,000.00, which includes all communication costs. These funds would come from the Transportation Services operating budget.

Summary

The purpose of this report is to obtain authority to install bicycle lanes on Stanley Avenue, Royal York Road, Simcoe Street, and Birchmount Road. This report is the third of several reports to obtain approval for installing bicycle lanes as part of the Toronto Bike Plan - 2008 Bikeway Network Program.

The implementation of the proposed bicycle lanes will result in an increase in the length of bicycle lanes in the City by 4.4 km. This will increase the total length of bicycle lanes approved and constructed from 96.4 km to 100.8 km of the total 495 km of bicycle lanes in the Toronto Bike Plan.

The affected Ward Councillors have been consulted and support the bicycle lanes proposed in their respective Wards.

Policy on Quantifying In-Kind Payments for Encroachment Agreements

(May 21, 2008) Report from the General Manager, Transportation Services.

Recommendations

The General Manager, Transportation Services recommends that:

1. City Council maintain the status quo related to the application of annual permit renewal fees for private encroachments within the City's public streets and consider requests for waiving such fees that may be received from time to time from cultural or other similar institutions on their individual situation and merits.

Financial Impact

Financial impact associated with maintaining the current approach of reviewing the infrequent requests to waive encroachment fees on a case by case basis as they arise would be minimal.

Summary

City Council, in considering a request from the Royal Ontario Museum to waive the annual permit renewal fee for the encroachment of a portion of the Michael Lee-Chin "Crystal" structure over the City's street allowance requested that this matter be reviewed in the context of Council's policies of community benefits relating to development approvals. We have concluded that these fees for encroachments are not analogous to donations or benefits derived in exchange for height or density considerations for development applications.

Requests to waive the annual permit renewal fees for encroachments are highly infrequent (less than one per year on average) and the circumstances in each case are unique. While staff does not recommend waiving the fees or substituting some other manner of meeting this obligation, it is recommended that Council continue to review any such requests on the basis of their individual fact situation and merits.

A separate report has also been submitted to Toronto and East York Community Council in order to arrive at a determination on the Royal Ontario Museum's specific request.

Committee Recommendations

The Public Works and Infrastructure Committee recommended that:

1. City Council maintain the status quo related to the application of annual permit renewal fees for private encroachments within the City's public streets and consider requests for waiving such fees that may be received from time to time from cultural or other similar institutions on their individual situation and merits.

Recommendations

Financial Impact

The total contract award for this report is \$70,432,993.09 including all applicable taxes and charges over the four-year contract term. The cost to the City net of GST is \$67,079,041.04. The engineering estimate for this project is \$68,629,000 net GST.

Funds for this contract are included under various operating and capital accounts. The following tables, Table 1 and Table 2, provide the relevant programs and forecasted funding between operating and capital budgets and cover the total cost of the project.

Forecasting the level of capital programs under this contract for the next four years, the respective capital for electrical traffic control devices under Contract 08TM-01TP is \$35,850,000. The amounts identified for each of these capital programs have been included in the Transportation Services 5-year Capital Plan. However, project cost and commitments of \$35,850,000 will need to be adjusted at the next Quarterly Capital Variance Report. There will be zero net debt impact as a result of this adjustment on the Approved 5-year Capital Plan for Transportation Services.

As shown in Tables 1 and 2, the Transportation Services Division's forecasted operating and capital amounts are \$31,244,000 and \$35,850,000, respectively, for the maintenance and operation of electrical traffic control devices. The funding for these activities covered under this contract commencing February 1, 2009, will be requested in subsequent annual Operating and Capital Budget submissions for each year of the contract period.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact statement.

The annual cost estimate of 3% growth is consistent with the increase in snow clearing, sanding and salting of sidewalks, bus bays, pedestrian crosswalks, and signalized intersections contract prices over the last 5 years. The total potential cost to the City is \$157,631,634.70 net of GST including an estimate of the annual cost adjustments using 3% per year after year 1. Funds needed between December 1 to December 31, 2008, will be provided in the Transportation Services Division's 2008 Operating Budget in the amount of \$5,142,982.47 net of GST from various operating accounts as noted in the table below. As a result of approval of the fifteen contracts, there is a potential to overspend the Winter Stabilization Reserve in the amount of approximately \$7 million in 2008. Part of this potential overage may be absorbed within the overall Transportation Services Approved 2008 Operating Budget. The General Manager of Transportation and the Deputy City Manager and Chief Financial Officer will continue to monitor the overall variances on a quarterly basis and will report back following the third quarter variance report, if necessary, on any additional required funding.

The remaining first winter's funding need between January 1 and March 31, 2009, in the amount of \$15,428,947.41, along with the first part of the second winter's adjusted cost, will be submitted for approval in the 2009 budget submission. The budget for the first winter season requirement is \$20,571,929.88 net of GST. The approval of the fifteen contract awards will require an increase in the Winter Maintenance Budget for 2009 to \$52 million from \$40 million in 2008. Contingencies have been built into the contracts that allow for an escalation to \$65 million if the City experiences a greater than average amount of snowfall in 2009; adjustments for technology, if required and expanded services required for any potential new roads.

The 2009 total Winter Maintenance Budget is subject to review through the 2009 operating budget process; following review of the 2008 Winter Maintenance actual spending experience.

Financial Impact

The total potential cost of the eighteen contract awards over the seven winter seasons is \$154,363,761.98 including all charges and applicable taxes and an estimate of the annual cost adjustments using 3% per year after year 1. The annual cost estimate of 3% growth is consistent with the increase in snow ploughing and driveway windrow clearing contract prices over the last 5 years. The total potential cost to the City is \$147,013,106.65 net of GST including an estimate of the annual cost adjustments using 3% per year after year 1. Funds needed between December 1 to December 31, 2008, will be provided in the Transportation Services Division's 2008 Operating Budget in the amount of \$4,487,144.63 net of GST from various operating accounts as noted in the table below. As a result of approval of the eighteen contracts, there is a potential to overspend the Winter Stabilization Reserve in the amount of approximately \$7 million in 2008. Part of this potential overage may be absorbed within the overall Transportation Services Approved 2008 Operating Budget. The General Manager of Transportation and the Deputy City Manager and Chief Financial Officer will continue to monitor the overall variances on a quarterly basis and will report back following the third quarter variance report, if necessary, on any additional required funding.

The remaining first winter's funding need between January 1 and March 31, 2009, in the amount of \$13,461,433.89, along with the first part of the second winter's adjusted cost, will be submitted for approval in the 2009 budget submission. The budget for the first winter season requirement is \$19,186,144.51 net of GST. The approval of the eighteen contract awards will require an increase in the Winter Maintenance Budget for 2009 to \$52 million from \$40 million in 2008. Contingencies have been built into the contracts that allow for an escalation to \$65 million if the City experiences a greater than average amount of snowfall in 2009; adjustments for technology, if required and expanded services required for any potential new roads.

The 2009 total Winter Maintenance Budget is subject to review through the 2009 operating budget process; following review of the 2008 Winter Maintenance actual spending experience.

Financial Impact

The increased amount in the purchase order amendment for winter maintenance on collector and local roads covered under Contract 47008031 to the end of the contract term on March 31, 2008 is \$648,632.88 excluding G.S.T.

The increased amount in the purchase order amendment for the supply of tri-axle dump trucks for snow removal operations covered under Contract 47013094 to the end of the contract term on March 15, 2008 is \$931,594.00 excluding G.S.T.

The total combined value of the contract value increases to Contracts 47008031 and 47013094 is \$1,580,226.88.

As a result of approval of these amendments, there is a potential to overspend the Winter Stabilization Reserve in the amount of approximately \$7 million in 2008. Part of this potential overage may be absorbed within the overall Transportation Services Approved 2008 Operating Budget. The General Manager of Transportation and the Deputy City Manager and Chief Financial Officer will continue to monitor the overall variances on a quarterly basis and will report back following the third quarter variance report, if necessary, on any additional required funding.

The Deputy City Manager and Chief Financial Officer has reviewed this report and agrees with the financial impact information.
