# Proposed Minor Street Stop Signs – Warden Woods (Summerside) Neighbourhood

#### **SUMMARY**

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report describes the need to install minor street stop signs at sixteen currently uncontrolled intersections and various standard traffic controls in a new development in the Scarborough Southwest Community.

The subdivision is located on the east side of Warden Avenue north of St.Clair Avenue East. It is recommended that minor street stop signs and/or all-way stops be installed at the sixteen intersections in order to clearly define the right-of-way and to regulate traffic flow. Moreover, the implementation of compulsory westbound turns at the intersection of Warden Avenue at Fairfax Crescent/Deans Drive would preclude traffic infiltration into the existing community to the west.

In addition, this report recommends a heavy truck prohibition on twelve new roads. This measure is being recommended as a standard practice for new local residential roadways.

#### RECOMMENDATIONS

## Transportation Services, Scarborough District, recommends that Scarborough Community Council:

- 1. Adopt the "Through Streets", "Compulsory Stops" and the "Heavy Truck Prohibition" regulations as identified in Appendix 1 and 2 of this report, and
- 2. Amend the appropriate by-laws accordingly.

#### Financial Impact

There is no financial impact as the funding for the signage on the subject roadways has been secured from the Developer.

#### **ISSUE BACKGROUND**

Further to a new development in the Warden Woods (Summerside) Neighbourhood, Transportation Services staff reviewed the need to provide the appropriate stop sign controls at the following locations within this development:

#### Compulsory Stop(s)

1. Ayers Crescent at Gerigs Street

All-Way Stop at the intersection of two collector type roadways

1. Howe Avenue at Tranter Trail/Yates Avenue, as the southwest portion of this intersection is designated park land.

Through Street Stop(s)

Deans Drive, Roper Road, Mendelssohn Street, Howe Avenue and Pidgeon Street will all be by-lawed under the "Through Street" by-law. Roadways intersecting these streets will automatically have a by-lawed stop control placed, as follows:

- 1. Tranter Trail at Mendelssohn Street
- Mendelssohn Street at Deans Drive
- 3. Ayers Crescent at Deans Drive
- 4. Gerigs Street at Tranter Trail
- 5. Gerigs Street at Deans Drive
- 6. Ferguson Street at Howe Avenue
- 7. Winkler Terrace at Howe Avenue
- 8. Pethick Street at Howe Avenue
- 9. Pethick Street at Pidgeon Street
- 10. Yates Avenue at Pidgeon Street
- 11. Winkler Terrace at Pidgeon Street
- 12. Ferguson Street at Pidgeon Street
- 13. Mendelssohn Street at Roper Road
- 14. Howe Avenue at Roper Road

A stop sign is required where Roper Road meets Warden Avenue; however, the authority to place this sign is already secured since Warden Avenue is currently by-lawed as a through street.

In addition, Transportation Services staff reviewed the need to provide a heavy truck prohibition by-law for all the new residential roads: Deans Drive, Roper Road, Mendelssohn Street, Howe Avenue, Pidgeon Street, Ayers Crescent, Gerigs Street, Ferguson Street, Winkler Terrace, Yates Avenue, Tranter Trail and Pethick Street. It is standard practice for the City to by-law new local and collector residential roadways with a heavy truck prohibition.

#### COMMENTS

The following characteristics describe the subject intersections:

- These intersections are located in the newly developed community east of Warden Avenue and north of St.Clair Avenue East.
- All roadways within this new development are two-lane local roadways with a
  pavement width of approximately 8.5 metres and a speed limit of 50 kilometres
  per hour (not signed).
- A sidewalk is located on one side of most roadways within the development.

Minor Street stop signs, Through Street stop signs and/or All-way stop signs at the subject sixteen intersections are recommended to clearly define the right-of-way.

Furthermore, in order to discourage truck parking on residential streets, and in conformity with the City's current practice, a heavy truck prohibition should also be implemented on the subject roadways.

The adoption of the traffic by-law amendments identified in Appendix 1 and 2 of this report will allow for proper enforcement of the respective traffic signs under the Highway Traffic Act.
