### Parking Regulation Housekeeping on Upton Road

#### SUMMARY

---

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report on Upton Road details the on-street parking regulation changes required to make the existing signed no parking prohibition enforceable, including a minor adjustment to improve the safety of a private access.

Community Council's approval of the parking regulation amendment will allow enforcement by the Toronto Police Service.

#### RECOMMENDATIONS

---

**Transportation Services, Scarborough District staff, recommends that Scarborough Community Council:**

1. Adopt the "No Parking" regulation, as identified in Appendix 1 of this report, and
2. Amend the appropriate by-laws accordingly.

#### Financial Impact

The financial cost for relocating one of the existing No Parking signs is approximately \$500.00. The funding for these signs is available in the Transportation Services 2008 Operating Budget, within Cost Centre TP0226.

## **ISSUE BACKGROUND**

There are currently “No Parking Anytime” signs posted on the south side of Upton Road along the frontage of numbers 11 and 15 Upton Road. This no parking zone keeps the accesses to these sites clear for trucking. While it appears that these signs have been in place for some time, for unknown reasons there does not appear to be any by-law in place to actually regulate these parking prohibitions.

Recently, Councillor Adrian Heaps, for the owner of 15 Upton Road, requested that the no parking zone be extended further east up to the easterly driveway to this address, in order to protect trucking access to this driveway as well. Staff concur with this minor adjustment.

## **COMMENTS**

The regulation will be amended to add a “No Parking Anytime” regulation for the south side of Upton Road from 75 metres east of the east limit of Warden Avenue to a point 70 metres further east, consistent with the current signs but including the minor easterly extension of the zone to protect the easterly access to 15 Upton Road.

In summary, the amended parking regulation will allow these signed parking prohibitions along Upton Road to be enforceable.
