SUMMARY

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report on Briar Dale Boulevard details the minor on-street parking and turning prohibition regulation changes required to make the existing posted prohibitions enforceable and to update the street name used in the regulations.

Community Council's approval of the parking regulation amendment will allow enforcement by the Toronto Police Services.

RECOMMENDATIONS

Transportation Services, Scarborough District, recommends that Scarborough Community Council:

- 1. Rescind the "No Parking" and "Prohibited Turns" regulations, as identified in Appendix 1 of this report,
- 2. Enact the "No Parking" and "Prohibited Turns" regulations, as identified in Appendix 2 of this report, and
- 3. Amend the appropriate by-laws accordingly.

Financial Impact

There is no financial impact associated with this report.

ISSUE BACKGROUND

There is currently a northbound "NO LEFT TURN 7AM – 9AM MON - FRI" prohibition posted at Hunt Club Road and Briar Dale Boulevard. While it appears that these signs have been in place for some time, for unknown reasons there does not appear to be any by-law in place to actually regulate this turn prohibition.

In addition, the spelling of "Briar Dale Boulevard" for other regulations that pertain to this street has been found to be incorrectly spelled as "Briardale Boulevard" for unknown reasons.

COMMENTS

The regulations will be amended to add a northbound left-turning prohibition from 7:00 a.m. to 9:00 a.m. Monday to Friday for the intersection of Hunt Club Road and Briar Dale Boulevard, consistent with the current signs.

The regulations will also be amended to reflect the current legal street name of Briar Dale Boulevard, to wit:

- a similar "No Left Turn" prohibition at Woodland Park Road and Briar Dale Boulevard, and
- "No Parking Anytime" prohibitions along Woodland Park Road and along Fallingbrook Road that terminate at Briar Dale Boulevard.

There will be no change in the actual posted parking or turning prohibitions.
