**SUMMARY**

---

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

This report on Victoria Park Avenue and Bracken Avenue details the minor on-street All-Way Stop Control and turning prohibition regulation changes required to make the existing posted prohibitions enforceable.

Community Council’s approval of the parking regulation amendment will allow enforcement by the Toronto Police Services.

**RECOMMENDATIONS**

---

**Transportation Services, Scarborough District, recommends that Scarborough Community Council:**

1. Rescind the “Compulsory Stops” and “Prohibited Turns” regulations, as identified in Appendix 1 of this report,
2. Enact the “Compulsory Stops” and “Prohibited Turns” regulations, as identified in Appendix 2 of this report, and
3. Amend the appropriate by-laws accordingly.

## **Financial Impact**

There is no financial impact associated with this report.

## **ISSUE BACKGROUND**

The intersection of Victoria Park Avenue and Bracken Avenue is currently signed with an All-Way Stop Control and a southbound “NO RIGHT TURN 6:30 a.m. to 9:30 a.m. , Monday to Friday, Bicycles Excepted” prohibition posted at Victoria Park Avenue and Bracken Avenue. It appears that these signs have been in place for some time and may have been regulated by pre-amalgamation City of Toronto By-Laws when Victoria Park Avenue was under joint jurisdiction between the former Cities of Scarborough and Toronto.

For unknown reasons there are inconsistent regulations in place under Scarborough By-law 23503, to wit, there is only a reference to one Compulsory Stop and a PM peak right-turning prohibition for a non-existent westbound leg at this intersection.

## **COMMENTS**

The regulations will be amended to remove the reference to the non-existent westbound leg at this intersection, to add proper regulations to legalise the All-Way Stop Control, and to add a southbound right-turning prohibition from 6:30 a.m. to 9:30 a.m. Monday to Friday – Bicycles Excepted consistent with the current signs. There will be no change in the actual posted All-Way Stop Control or turning prohibition.
