#### **SUMMARY**

The purpose of this report is to recommend the Scarborough Community Council establish a board of management for the Crossroads of the Danforth BIA and approve the nominees to the board. The Scarborough Community Council has delegated authority to establish BIA boards of management and to make final decisions regarding BIA appointments.

#### RECOMMENDATIONS

#### The Director of Business Services recommends that:

- 1. Scarborough Community Council establish a board of management for the Crossroads of the Danforth BIA as set out in Attachment No. 1.
- 2. Scarborough Community Council approve the nominations to the Crossroads of the Danforth BIA board of management as set out in Attachment No. 2.
- 3. Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to include the new Crossroads of the Danforth BIA.

#### ISSUE BACKGROUND

City Council established the Crossroads of the Danforth Business Improvement Area on June 24, 2008. At its first annual general meeting on October 21, 2008, the BIA elected board members and approved its 2009 budget in accordance with Chapter 19 of the City of Toronto Municipal Code.

#### COMMENTS

It is recommended that the Scarborough Community Council establish a board of management for the Crossroads of the Danforth BIA, consisting of the 5 nominees listed in Attachment No. 2 and the local Councillor for Ward 35, with a quorum of 3 members.
