SUMMARY

This staff report is about a matter for which the Community Council has delegated authority from City Council to make a final decision.

While reviewing area signage, as a result of vehicle speed and volume studies in the Meadowacres Drive area, Transportation Services staff identified an uncontrolled three-way intersection in the immediate area (Foxhill Road at Bugle Hill Road).

It is recommended that a minor street stop sign be installed at the subject uncontrolled three-way intersection to clearly define the right-of-way and to regulate traffic flow.

RECOMMENDATIONS

Transportation Services, Scarborough District, recommends that Scarborough Community Council:

1. Adopt the “Compulsory Stops” regulation, as identified in the Appendix 1 of this report.
2. Amend the appropriate by-law accordingly.

Financial Impact

The financial cost of installing the subject recommended stop control is approximately \$250.00. The funding for this stop control is available in the Transportation Services 2008 Operating Budget, within Cost Centre TP0397.

ISSUE BACKGROUND

Further to a request from Councillor Kelly, Transportation Services staff reviewed traffic volumes and speeds along Meadowacres Drive. No changes to the operation of Meadowacres Drive are recommended at this time; however, a review of area signage identified an uncontrolled three-way intersection in the immediate area (Foxhill Road at Bugle Hill Road).

COMMENTS

The following characteristics describe the subject intersection of Foxhill Road at Bugle Hill Road:

- This three-way intersection is located in the community east of Victoria Park Avenue and south of Sheppard Avenue East, within the Tam O'Shanter-Sullivan neighbourhood.
- There are no sidewalks on either Foxhill Road or Bugle Hill Road.

Minor street stop signs are recommended, to provide stop sign uniformity, clearly define the right-of way and to enhance driver and pedestrian safety, at the following location:

1. Foxhill Road at Bugle Hill Road

When installed, the subject stop sign will help to clarify road right-of-way, regulate traffic flow and enhance public safety.
