Good Afternoon Bob,

As per our conversation earlier today, concerning the sightlines on Hiscock Boulevard at #839 Brimorton Drive, attached below are the photos and an electronic copy of my e-mail from August 3, 2007 you requested.

Please note that as per my August 3, 2007 e-mail, it has been determined that the encroachment in the public boulevard of the approximate 6 foot high wood fence *does not obstruct* the sightlines at the intersection of Hiscock Boulevard and Brimorton Drive. Our operational review indicates that a driver looking right while stopped at the stop bar for eastbound traffic on Hiscock Boulevard at Brimorton Drive can clearly see past the fence and see the Brimorton Drive roadway all the way to the traffic signals at Scarborough Golf Club Road (see attached photo).

The fence does partially obstruct the sight line of the sidewalk along Brimorton Drive but pedestrians have plenty of time to see a vehicle approaching the stop sign. However, a fence height of 1.0 metres for the boulevard encroachment would allow pedestrians on the sidewalks to see each other.
