Victoria Street - Reinstate Traffic and Parking Regulations

SUMMARY

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision.

The construction of the Metropolis development at 10 Dundas Street East has been completed. The temporary traffic and parking regulations that were implemented on Victoria Street, between Dundas Street East and Gould Street, for the construction of the building can now be removed.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council approve the following actions:

- 1. Rescind the existing one-way northbound traffic operation on Victoria Street, between Dundas Street East and Gould Street.
- 2. Rescind the existing "No Stopping Anytime" regulation on the east side of Victoria Street, between Dundas Street East and Gould Street.
- 3. Implement a "No Parking Anytime" regulation on the east side of Victoria Street, between Dundas Street East and Gould Street.

Financial Impact

There is no financial impact on the City. PCL Constructors Canada Inc. will bear the costs.

DECISION HISTORY

City Council, at its meeting of June 7, 8 and 9, 2000, in considering Clause No. 21 of Report No. 9 of the Toronto Community Council, among other things, approved the one-way northbound operation on Victoria Street, between Dundas Street East and Gould Street and the implementation of a "No Stopping Anytime" zone on the east side of the street, to set up a construction staging area on the west side of Victoria Street to build the Metropolis retail complex at 10 Dundas Street East.

ISSUE BACKGROUND

The staff report advised that Transportation Services will report back to Toronto Community Council to restore the current traffic operations and parking regulations on Victoria Street when the project is completed. Transportation Services has been advised by PCL Constructors Canada Inc. that construction of the building is complete.

COMMENTS

Since the project is now complete, the original traffic operations and parking regulations can be reinstated on Victoria Street, between Dundas Street East and Gould Street. Two-way traffic can be reinstated on this block and the original "No Parking Anytime" regulation can be reinstated on the east side of the street. The TTC does not operate transit service on this section of Victoria Street.
