Whitewood Road – Reduction of Overnight On-Street Permit Parking Hours

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to reduce the overnight on-street permit parking hours on Whitewood Road, between Davisville Avenue and Millwood Road, from 12:01 a.m. to 7:00 p.m., 7 days a week, to 12:01 a.m. to 7:00 a.m., 4:00 p.m. to 7:00 p.m., Monday to Friday, and 12:01 a.m. to 7:00 p.m., Saturday and Sunday.

The reduction of the overnight on-street permit parking hours would allow non permit holders, such as visitors and tradespersons, to park during non-permit parking hours, without being subject to tagging by Parking Enforcement.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. reduce the overnight on-street permit parking hours of operation on Whitewood Road, between Davisville Avenue and Millwood Road, from 12:01 a.m. to 7:00 p.m., 7 days a week, to 12:01 a.m. to 7:00 a.m., 4:00 p.m. to 7:00 p.m., Monday to Friday, and 12:01 a.m. to 7:00 p.m., Saturday and Sunday; and

2. parking be permitted for a maximum period of two hours from 7:00 a.m. to 4:00 p.m., and from 7:00 p.m. to 12:01 a.m., Monday to Friday, and from 7:00 p.m. to 12:01 a.m., Saturday and Sunday, on the east side of Whitewood Road.

ISSUE BACKGROUND

A request was received from Councillor Michael Walker, on behalf of area residents, to reduce the overnight on-street permit parking hours on Whitewood Road, between Davisville Avenue and Millwood Road, from 12:01 a.m. to 7:00 p.m., 7 days a week, to 12:01 a.m. to 7:00 a.m., 4:00 p.m. to 7:00 p.m., Monday to Friday, and 12:01 a.m. to 7:00 p.m., Saturday and Sunday. Councillor Walker also requested the temporal parking duration, during non-permit parking hours, be amended from three hours to two hours.

COMMENTS

Whitewood Road, between Davisville Avenue and Millwood Road, is a local street operating in a two way north/south bound direction with a pavement width of 8.5metres. Currently parking is allowed on the east side of the street for a maximum period of three hours outside of the permit parking operating hours of 12:01 a.m. to 7:00 p.m.

A Public Notice was placed in a major newspaper on January 24, 2008, with an expiration date to raise objections of February 7, 2008. The Clerk has confirmed that no written objection was received by the expiration date.

There is no TTC service on Whitewood Road.

Area residents requested the reduction of the on-street permit parking hours and the change to the temporal parking duration to alleviate the problem of tagging of their guests and tradespersons.
