**Brock Avenue, Emerson Avenue, Margueretta Street,
Pauline Avenue and St. Clarens Avenue – Extension of
Overnight On-Street Permit Parking Hours**

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Brock Avenue, between Bloor Street West and Wallace Avenue, Emerson Avenue, between Bloor Street West and Wallace Avenue, Margueretta Street, between Bloor West and Wallace Avenue, Pauline Avenue, between Bloor Street West and Wallace Avenue, and St. Clarens Avenue, between Bloor Street West and Wallace Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week.

By extending the overnight on-street permit parking hours, the Parking Enforcement Unit, Toronto Police Service, can effectively control long term commuter parking.

RECOMMENDATIONS

Transportation Services recommends that Toronto and East York Community Council:

1. extend the overnight on-street permit parking hours of operation on Brock Avenue, between Bloor Street West and Wallace Avenue, Emerson Avenue, between Bloor Street West and Wallace Avenue, Margueretta Street, between

- Bloor West and Wallace Avenue, Pauline Avenue, between Bloor Street West and Wallace Avenue, and St. Clarens Avenue, between Bloor Street West and Wallace Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week;
2. rescind the 1 hour parking regulation from 8:00 a.m. to 6:00 p.m., daily, on St. Clarens Avenue, between Bloor Street West and Wallace Avenue; and
 3. allow parking for a maximum period of 1 hour from 10:00 a.m. to 6:00 p.m., daily, on St. Clarens Avenue, between Bloor Street West and Wallace Avenue.

ISSUE BACKGROUND

A request was received from Councillor Adam Giambrone, on behalf of area residents, for the extension of overnight on-street permit parking hours on Brock Avenue, between Bloor Street West and Wallace Avenue, Emerson Avenue, between Bloor Street West and Wallace Avenue, Margueretta Street, between Bloor West and Wallace Avenue, Pauline Avenue, between Bloor Street West and Wallace Avenue, and St. Clarens Avenue, between Bloor Street West and Wallace Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 12:01 a.m. to 10:00 a.m., 7 days a week.

COMMENTS

Brock Avenue, between Bloor Street West and Wallace Avenue, is a local street operating in a one way southbound direction with a pavement width of 7.32 metres. Currently parking is prohibited on the east side of the street, except Thursdays, from April 1 to November 30. On the west side of the street, parking is allowed for a maximum period of 3 hours, except Thursdays, from April 1 to November 30, with permit parking in effect from 12:01 a.m. to 7:00 a.m., 7 days a week.

Emerson Avenue, between Bloor Street West and Wallace Avneue, is a local street operating in a one way southbound direction with at a pavement width of 7.32 metres. Currently parking operates on an alternate side basis and is allowed for a maximum period of 3 hours, with permit parking in effect during the hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

Margueretta Street, between Bloor Street West and Wallace Avenue, is a local street operating in a one way northbound direction with a pavement width of 7.32 metres. Currently parking operates on an alternate side basis and is allowed for a maximum period of 3 hour between the hours, with permit parking in effect during the hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

Pauline Avenue, between Bloor Street West and Wallace Avenue, is a local street operating in a one way northbound direction with a pavement width of 7.32 metres. Currently parking is prohibited on the west side of the street, except Thursdays, from April 1 to November 30. On the east side of the street, parking is allowed for a maximum period of 3 hours, except Thursdays, from April 1 to November 30, with permit parking in effect from 12:01 a.m. to 7:00 a.m., 7 days a week.

St. Clarens Avenue, between Bloor Street West and Wallace Avenue, is a local street operating in a one way northbound direction with a pavement width 7.32 metres. Currently parking operates on an alternate side basis and is allowed for a maximum period of 1 hour from 8:00 a.m. to 6:00 p.m., daily, with permit parking in effect during the hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

There is no TTC service on Brock Avenue, Emerson Avenue, Margueretta Street, Pauline Avenue and St. Clarens Avenue.

Area residents requested the extension of on-street permit parking hours from 7:00 a.m. to 10:00 a.m., to alleviate the problem of long term commuter parking.
