I would like to seek your advice and assistance concerning a Stadium License for Massey Hall where our licensed bar areas can hold only a fraction of our audiences. The result is that people often spend the entire intermission trying to get to a bar but receive nothing but frustration. If we could get a license that allows patrons to take their drinks into the auditorium it would go a long way toward alleviating this problem. At the moment we typically end up with scores of unhappy patrons reentering the hall for the second part of the program. This obviously does not help the with the ambiance of the concert and ends up we fear losing us repeat patronage.
