Notice was given and a Public Hearing was held on Wednesday, February 27, 2008, as required by the Planning Act.

#### PURPOSE OF THE APPLICATION:

To expand the existing restaurant to the second floor of the building and to construct a rear one-storey ground floor addition. The existing rear ground floor outdoor patio will be maintained.

## REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

1. Section 8(3) Part I 2, By-law 438-86

The non-residential gross floor area shall not exceed 1.0 times the area of the lot  $(169.4 \text{ m}^2)$ . The altered building will have a non-residential gross floor area equal to 1.02 times the area of the lot  $(173.07 \text{ m}^2)$ .

2. Section 12(2)318 1(b), By-law 438-86

The proposed use of "restaurant" is permitted in the building, but limited to the ground floor. The restaurant will be expanded to the second floor.
