# **Business Improvement Area (BIA) Boards of Management - Various Additions and Deletions**

## **SUMMARY**

The purpose of this report is to recommend Toronto and East York Community Council approve additions and deletions to the Bloor-Yorkville, Danforth Mosaic, Korea Town, Little Portugal, Pape Village, Parkdale Village, Rosedale Main Street, St. Lawrence Market Neighbourhood, and Toronto Entertainment District BIA Boards of Management. The Toronto and East York Community Council has delegated authority to make final decisions regarding BIA appointments.

## RECOMMENDATIONS

#### The Director of Business Services recommends that:

- 1. Toronto and East York Community Council approve the additions and deletions to the Bloor-Yorkville, Danforth Mosaic, Korea Town, Little Portugal, Pape Village, Parkdale Village, Rosedale Main Street, St. Lawrence Market Neighbourhood, and Toronto Entertainment District Boards of Management as set out in Attachment No. 1.
- 2. Schedule A of the Municipal Code Chapter 19, Business Improvement Areas, be amended to reflect the changes to the BIA Boards of Management.

## **Financial Impact**

There are no financial implications resulting from the adoption of this report.

#### **ISSUE BACKGROUND**

From time to time, it is necessary to remove BIA Board of Management members who are no longer able to serve, add new members to fill vacant positions, and revise the size of BIA Boards and the number required for quorum as set out in Chapter 19 of the City of Toronto Municipal Code.

#### COMMENTS

The Bloor-Yorkville, Danforth Mosaic, Korea Town, Little Portugal, Pape Village, Parkdale Village, Rosedale Main Street, St. Lawrence Market Neighbourhood, and Toronto Entertainment District BIAs are governed by the Toronto and East York Community Council.

The resignation of one member and addition of one member to the Bloor-Yorkville BIA Board of Management will not affect the number of Board members or quorum.

The resignation of one member of the Danforth Mosaic BIA Board of Management will require a change to the number of Board members from 17 to 16 (including four councillors). Quorum will be unchanged.

The resignation of four members and addition of one member to the Korea Town BIA Board of Management will require a change to the number of Board members from 14 to 11 (including two councillors). Quorum will be reduced from 6 to 5.

The resignation of one member of the Little Portugal BIA Board of Management will require a change to the number of Board members from 17 to 16 (including two councillors). Quorum will be unchanged.

The resignation of one member and addition of one member to the Pape Village BIA Board of Management will not affect the number of Board members or quorum.

The resignation of four members and addition of two members to the Parkdale Village BIA Board of Management will require a change to the number of Board members from 14 to 12 (including one councillor). Quorum will be reduced from 8 to 6.

The resignation of four members of the Rosedale Main Street BIA Board of Management will require a change to the number of Board members from 15 to 11 (including two councillors). Quorum will be reduced from 5 to 4.

The resignation of three members of the St. Lawrence Market Neighbourhood BIA Board of Management will require a change to the number of Board members from 17 to 14 (including one councillor). Quorum will be reduced from 8 to 7.

The resignation of one member of the Toronto Entertainment District BIA Board of Management will require a change to the number of Board members from 20 to 19 (including two councillors). Quorum will be reduced from 10 to 9.
