### Extension of Overnight On-Street Permit Parking Hours - Carlaw Avenue

#### SUMMARY

---

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend overnight on-street permit parking hours on Carlaw Avenue, between Danforth Avenue and Harcourt Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 10:00 p.m. to 10:00 a.m., 7 days a week. In addition, we have received a request to alter the current three hour temporal parking duration to one hour, between the hours of 10:00 a.m. to 10:00 p.m., 7 days a week.

By extending overnight on-street permit parking hours and adjusting the temporal parking duration to one hour, the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by nearby business patrons through their tagging and towing operations.

#### RECOMMENDATIONS

**Transportation Services recommends that Toronto and East York Community Council:**

1. approve the extension of overnight on-street permit parking hours of operation on Carlaw Avenue, between Danforth Avenue and Harcourt Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 10:00 p.m. to 10:00 a.m., 7 days a week;

2. allow parking for a maximum period of one hour from 10:00 a.m. to 10:00 p.m., 7 days a week.

### **ISSUE BACKGROUND**

A request was received from Councillor Paula Fletcher, on behalf of area residents, for the extension of overnight on-street permit parking hours on Carlaw Avenue, between Danforth Avenue and Harcourt Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week, to 10:00 p.m. to 10:00 a.m., 7 days a week and to alter the current 3 hour parking duration to one hour, between the hours of 10:00 a.m. and 10:00 p.m., 7 days a week.

### **COMMENTS**

Carlaw Avenue, between Danforth Avenue and Harcourt Avenue, is a local street operating one way southbound, on a pavement width of 7.3 metres. No TTC service operates on the subject section of Carlaw Avenue. Currently parking is allowed for a maximum period of three hours on the east side of the street with overnight on-street permit parking in effect from 12:01 a.m. to 7:00 a.m., 7 days a week. Parking is prohibited at all times on the west side of the street.

Area residents requested the extension of overnight on-street permit parking hours on Carlaw Avenue, between Danforth Avenue and Harcourt Avenue, to alleviate the problem of long term parking by nearby business patrons.
